- Chad Dawson, Recreation Coordinator Sports, received a letter of recognition and event endorsement from the California Governor's Council – Arnold Schwarzenegger on December 20, 2005 (included in your packet as FYI).

#### CITY COUNCIL COMMUNICATION

- Numerous personnel issues the city is currently experiencing with long-time employees retiring, training new hires, etc.
- City Council will be making a decision about the Melody Park basin drain storm/flood retention in a public workshop and closing this project in April 2006.
