NEEDS:	For the City Council to consider approval of limited time parking restrictions (yellow curb and loading zone rules signage) on the 13 <sup>th</sup> Street side of the Great American Antiques Mall at 1305 Spring Street.
FACTS:	1. The City is in receipt of a letter form Mr. Michael J. Garrotto, owner of Great American Antiques, requesting the reinstallation of yellow curb (loading zone) on the 13 <sup>th</sup> Street side of his business at 1305 Spring Street.
	2. The Streets and Utilities Committee considered this request at their February 24, 2006 meeting. The committee voted 2-0 to recommend City Council approval of the installation 22 feet of yellow curb and loading zone rules signage.
Analysis and Conclusion:	Over the past year, City staff has been in the process of surveying and documenting curb markings within the City limits. The purpose of this survey is to determine which curb markings were authorized and which were not authorized. Downtown curb markings that fell into the undocumented category were removed. Mr. Garrotto's yellow curb was one such instance.
	Mr. Garotto contacted the City and stated that the yellow curb is necessary to the operation of his business. He was advised to file a request for a loading zone with the Streets and Utilities committee. The city received the request letter January 6, 2006.
	A loading zone (yellow curb) at this location will decrease downtown parking by one space. Mr. Garatto states that the loading zone is needed to load and unload 50 items per week.
FISCAL IMPACT:	Cost of paint, signage & staff time for Public Works (\$300) plus cost of enforcement for Police Department.
OPTIONS:	a. Approve 22 feet of yellow curb (loading zone designation) and signage on the 13 <sup>th</sup> Street side of the Great American Antique Mall at 1305 Spring Street.
	<b>b.</b> Amend, modify, or reject the above option.

Great American Antiques Mall, located at 1305 Spring Street, would like the city of Paso Robles to repaint the loading zone which has been located on the 13th street side of the store for the last nine years.
