| | b. Having submitted an annual Housing Element Progress Report to HCD by October 31, 2004; | | |
| | c. Having given "final land use approval" and issued a building permit, in Calendar Year 2004, to a housing project reserved for low income households. The qualifying housing project was Canyon Creek Apartments (Peoples Self-Help Housing Corp.'s 68 unit low income apartments at 400 Oak Hill Road). | | |
| | 3. At its meeting of August 16, 2005, the City Council approved the following list of eligible projects for accomplishment/assistance with WFH funds: | | |
| | a. Install curbs, gutters, sidewalk, street light on 28th Street, in front of Oak Park Senior Housing Project (estimated cost of \$167,000); | | |

| | On April 12, 2006, the City solicited bids for the 28th Street Improvement Project. Bids will open on May 16. The Council is tentatively scheduled to award a contract on June 6, 2006. | | |

| Analysis and Conclusion: | In order to award a contract for the 28 th Street Improvements Project, an appropriation of \$167,000 will be needed. The remainder of \$74,800 (rounded) can be appropriated to one or more of the other three projects. | |

| | Based on the recent contract awarded to install an LED-Lighted Crosswalk at 34 th and Spring Streets, the \$74,800 remainder could cover two additional crosswalks. And, the attached resolution is drafted to accommodate such an option. | |

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES APPROPRIATING WORKFORCE HOUSING GRANT FUNDS

WHEREAS, on June 30, 2005, the State Department of Housing and Community Development (HCD) awarded the City \$241,767 in Workforce Housing (WFH) Grant funds; and

WHEREAS, at its meeting of August 16, 2005, by minute action, the City Council of the City of El Paso de Robles (City) approved the following list of potential projects for use of WFH Grant funds:

- a. Install curbs, gutters, sidewalk, street light on 28th Street, in front of Oak Park Senior Housing Project (estimated cost of \$167,000);
- b. Install LED-lighted crosswalks at several locations (estimated cost of \$140,000);
- c. Install curbs, gutters, sidewalk in Riverside Avenue adjacent to the Fairgrounds Parking Lot (estimated cost of \$295,000);
- d. Install paving, curbs, gutters, sidewalk (one side) on Vine Street, between Marion Avenue and 36th Street (estimated cost of \$365,000); and

WHEREAS, In its Agreement for the WFH Grant, HCD has stipulated that all grant funds must be encumbered by June 30, 2006 and spent by June 30, 2008; and
