

**TO:** James L. App, City Manager

**SUBJECT:** Repair of City Landfill Access Road  
**DATE:** June 20, 2006

---

**NEEDS:** For the City Council to consider appropriating \$25,000 and award of a contract to Ferravanti Grading and Paving to repair the access road to the City Landfill.

**FACTS:**

1. A section of the access road into the City Landfill has settled significantly and is causing a potential safety hazard to the commercial and public vehicles using the landfill.
2. Pacific Waste Services, the City's contract landfill operator is responsible for maintenance of all roads inside the landfill. The City is responsible for maintenance of the access road from Highway 46 to the landfill entrance.
3. In accordance with the Uniform Code for Cost Accounting, the City requested written quotations from three reputable contracting firms. Bid results were as follows:

Ferravanti Grading and Paving	\$21,000.00
Mitch Frederick	\$24,620.00
Viborg Sand and Gravel	\$28,105.00

**ANALYSIS  
AND**

**CONCLUSION:** The City is obligated to maintain the access road into the City landfill. A section of the road has experience significant settlement and needs to be repaired. The California Integrated Waste Management Board inspector has noted the settlement on their recent inspection reports as an area of concern and has requested the City to implement the repair as soon as possible. The low bid was \$21,000.00. Staff is requesting \$25,000.00 be allocated to provide a contingency should any unforeseen conditions associated with the road be discovered in conjunction with the repair process.

**POLICY**

**REFERENCE:** Purchasing Procedures Manual and Agreement for Operation of Paso Robles Municipal Landfill

**FISCAL**

**IMPACT:** The City's Solid Waste Contingency Fund, established to deflect landfill related costs from impacting the General Fund, has \$72,700 in available resources. Staff recommends that the cost to repair the entrance roadway be funded from this source.

**OPTIONS:**

- a. Adopt Resolution No. 06-xx appropriating \$25,000 from the Solid Waste Contingency Fund to Budget account 612-910-5452-300 and direct the City Manager to enter into a contract in the amount of \$21,000 with Ferravanti Grading and Paving to repair the access road per the attached Proposal.

**b.** Amend, modify, or reject the above option.
