WHEREAS, at the Bid Opening on June 29, 2006, four bids were received ranging from a low bid of \$22,248.40 to a high bid of \$35,541.00; and

WHEREAS, staff reviewed the low bid submitted by Central Coast Striping and finds it to be a responsive bid.

SECTION 1. The City Council of the City of El Paso de Robles does hereby award a contract to Central Coast Striping in the amount of \$22,248.40 to perform the City's Annual Street Striping project, DPW No. 04-08.

**NEEDS:** For the City Council to consider adopting Resolution No. 06-xx to award a construction contract to Central Coast Striping for the City's annual street striping maintenance.

**FACTS:**

1. The City's Street Maintenance Budget allocates \$22,500 (Budget No. 213.310.5235.162) towards the maintenance of the City's striping to be performed by a contractor.
2. At the bid opening on June 29, 2006, four bids were received as follows:

Central Coast Striping	\$22,248.40
PCI	\$27,548.50
Chrisp Company	\$29,685.00
Superior Pavement Markings	\$35,541.30
3. Staff reviewed the low bid submitted by Central Coast Striping in the amount of \$22,248.40 and found it to be a responsive bid.
