NEEDS:

For the City Council to consider awarding the purchase of 18,000 pounds of Pulsar Plus Chlorine Briquettes over a period of twelve months from Knorr Systems Inc.

FACTS:

- 1. The City currently operates and maintains two public swimming pools (Municipal & Centennial) that use the Pulsar Chlorination system for sanitation purposes.
- 2. In an attempt to purchase product at the most economical price, and to ensure availability, bids were solicited for a year supply of briquettes.
- 3. Materials and specifications were drafted and advertised per the City of Paso Robles Purchasing and Payment Procedures Manual.
- 4. Three bids were received and opened on June 29, 2006. The bids ranged from a low bid of \$39,399.50 to a high bid of \$47,490.30.
- 5. The low bid of \$39,399.50 submitted by Knorr Systems Inc. was reviewed and deemed a responsive bid.

ANALYSIS

AND

CONCLUSION: The City operates and maintains two commercial pools. The Pulsar Chlorination system

is currently being utilized. This system is dependent upon the use of Calcium Hypochlorite Briquettes. Purchasing a year's supply provides the best price and ensures

availability of the product.
