4. On July 17, 2006 the City Clerk posted and circulated a Notice of Vacancy for the CTAC position, consistent with government code.

5. Two applications were received by the filing deadline of July 28, 2006

(see attached).

6. The City's appointment to CTAC serves at the pleasure of the City Council with no specific term. The next scheduled CTAC meeting is

Wednesday, September 20, 2006.

ANALYSIS &

CONCLUSION: There are two applicants for the one vacant position on CTAC. The

City Council could either schedule a date for applicant interviews prior to appointment, or make an appointment to the committee based on the

information contained in the applications submitted.
