Needs: For the City Council to consider adoption of a resolution declaring certain City

property as surplus and authorize its disposal.

Facts:

- 1. City vehicles and office equipment are replaced in accordance with the approved budget based upon replacement schedule maintained by Administrative Services.
- 2. The replaced vehicles are no longer servicable for City operations.
- 3. The office equipment, personal computers, will be disposed of in accordance with past practice, sell to employees at fair market value.
- 4. Disposal of said equipment can not take place until formally declared surplus by the Council.
- 5. Proceeds from the sale of the surplus equipment will be deposited back into the equipment replacement, or appropriate enterprise, fund.

Analysis & Conclusion:

The vehicles and personal computers identified in the attached exhibit are no longer being used by the City. Vehicles declared surplused will be sold at public auction and, as noted above, personal computers will be first offered to City employees at fair market value.

Fiscal Impact:

Sale proceeds will be deposited back into the appropriate fund.

Options:

- a. Adopt Resolution No. 06-xxx declaring certain City property as surplus and authorize their sale by public auction, bid or sale; or
- b. Amend, modify, or reject the above option.
