SUBJ: Supplemental Law Enforcement Service Fund

DATE: September 19, 2006

NEEDS:

For the City Council to consider accepting up to \$100,000 from the California State Supplemental Law Enforcement Service Fund (SLESF) and to consider approving a revised expenditure plan for all SLESF monies.

FACTS:

- 1. The City of Paso Robles received \$100,000 in both FY 2005 and 2006 from the California State Supplemental Law Enforcement Services Fund (SLESF). This money was saved with a plan to pay for a large Mobile Data Computer (MDC) project.
- 2. During fiscal year 2007, it is anticipated that the City of Paso Robles will again receive up to \$100,000 from the California State Supplemental Law Enforcement Services Fund.
- 3. Existing law requires the County Auditor to allocate all monies received from the Supplemental Law Enforcement Services Fund (SLESF) within 30 days of deposit of those monies. A modification to this law requires that before the County Auditor can disperse these funds, a copy of an approved expenditure plan from each City Council or Board of Supervisors be submitted to the Supplemental Law Enforcement Service Fund Oversight Committee for review and certification.
- 4. With receipt of the FY 2007 SLESF funding, the City will have just under \$300,000 set aside for this project.
- 5. The Police Department fully intends to continue pursuit of MDC procurement and implementation during FY2007; however, the project has experienced delays due to its magnitude and complexity and previously set aside funds from FY 2005 are not expected to be completely spent this fiscal year.
- 6. The FY 2005 funds previously set aside must be expended by June 30, 2006.
- 7. The Police Department is submitting a revised expenditure plan that calls for changes in how the accumulated SLESF funds are to be expended; whereby, FY 2005 and partial FY 2006 funding of approximately \$107,500 will be spent on various equipment, technology and services to support frontline law enforcement activities; and, remaining funds of approximately \$190,000 from FY 2006 and 2007 will be utilized for the MDC project as it moves forward.
- 8. A noticed public hearing must be held with public comment allowed, either written or oral, regarding the proposed use of these grant funds. This will

be accomplished at the regularly scheduled City Council meeting during their review of this staff report. Public comment will be invited.

ANALYSIS & CONCLUSION:

The Paso Robles Police Department is revising its expenditure plan for the California State Supplemental Law Enforcement Service Funds (SLESF). Since FY 2005, we have accumulated approximately \$300,000 for expenditure on equipment, technology and services to enhance frontline law enforcement. FY 2005 money must be spent by June 30, 2007, and although it had been previously earmarked for the Mobile Data Computer (MDC) project, it is now our intention to spend approximately \$107,500 on other equipment, technology and services. The remaining funds for fiscal years 2006 and 2007 will be earmarked for the MDC project as it continues to progress through procurement and implementation. (See Table A)

The expenditure plan detailed in the table exceeds our total \$300,000 allocation by approximately \$15,000. This fund is interest bearing and may provide additional funding to accomplish all of these purchases. This list is intended to provide direction for the organization without limiting flexibility in administrative decision making. Minor variances in final procurement decisions may be made based on identified need.

\$100,000 new revenue source to fund #117-210-5235-136 for funding future Mobile Data Computer Project, with current earmarked FY 2005 funds to be redirected for expenditure on items identified in Table A.

WHEREAS, the City of El Paso de Robles Police Department is eligible for funds up to \$100,000 from the Supplemental Law Enforcement Service Funds ("SLESF"); and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council of the City of El Paso de Robles does authorize acceptance of Supplemental Law Enforcement Service Funds in the amount of \$100,000 (maximum) and approves the associated expenditure plan for fiscal years 2005 through 2007.

BE IT ALSO RESOLVED, that Council approves a one-time budget appropriation from the SLESF grant fund in the amount of \$100,000 to budget account 117-210-5235-136 to fund purchase identified in the expenditure plan.
