Needs:

That the City Council authorizes the acceptance of an Irrevocable and Perpetual Offer of Dedication, for an easement for water, sewer and other underground utilities, provided by Beatrice Howell. The easement is related to the construction of sewer and water lines needed to serve Tract 2782 on Experimental Station Road.

Facts:

- 1. The Planning Commission approved Tentative Tract 2782 on November 22, 2005. The conditions of approval reflect that the development of Tract 2782 depends on the extension of utilities, including sewer and water lines, from adjacent Tract 2005, Jena Court.
- 2. The City has received a 20-foot wide Irrevocable and Perpetual Offer of Dedication for an easement for sewer, water and other underground utilities across Lot 5 of Tract 2005, as required by the approved tentative tract map.




