Needs:

For the City Council to consider setting the date for interviews of candidates for filling vacancies on the Citizen's Airport Advisory Committee ("CAAC").

#### Facts:

- 1. The Committee consists of five (5) regular appointed members and one (1) alternate who are each assigned in staggered two year terms.
- 2. Three of the regular appointed committee members' terms will expire October 31, 2006. The seats are currently occupied by Eric Cook, Ronald Rose, and the seat vacated by Michael Weber in May 2006.
- 3. On July 5, 2006 the City Council voted to postpone the interviews for vacated seat as the alternate committee member continued to receive agenda material and participated in committee matters.
- 4. A recruitment notice for the CAAC vacancies was placed in local newspapers and posted on the City's website. At the close of the application deadlines of September 22, 2006, a total of five applications were received for the three vacancies.
