SUBJECT: **Downtown Promotion Service Agreement**

DATE: November 7, 2006

FACTS:

NEEDS: For the City Council to consider a one-year extension of the agreement with the Paso Robles Main Street for downtown promotion services.

> 1. The City's 2003 General Plan established a vision for Paso Robles as a place where one could "live, work, and shop." The community's 2006 Economic Development Strategy identifies strategies to achieve that vision.

- 2. The Economic Development Strategy includes expansion and promotion of the downtown.
- 3. To that end, the City seeks continued assistance from Paso Robles Main Street to promote downtown business.
- 4. Paso Robles Main Street has provided downtown promotion services to the City for more than a decade.
- 5. During the term of their service, the downtown has experienced a rebirth, and significant expansion, of commerce and activity.
- 6. Payments to Main Street most recently have been \$78,100 for FY 2006 services.
- The Council appointed an ad hoc committee, Gary Nemeth & Fred Strong, to review the agreement with Main Street against the objectives of the 2006 Economic Strategy.
- The Council Committee has met with Main Street staff and Board representatives. A one-year extension of the agreement is recommended.

ANALYSIS &

CONCLUSION: Current and earlier agreements with Main Street provided payment for "special knowledge and experience to focus on the organization, promotion, design, and economic restructuring necessary to accomplish revitalization within the City's Redevelopment Project Area, especially the historic downtown, and the goals of the Economic Development Strategy. The proposed agreement extension includes provisions to continue these same services. Given the City's long-standing and successful contract relationship with Main Street, assurance of continued service is central to ongoing efforts to continually improve and enhance downtown commerce

and activity. To that end, the Council ad hoc committee recommends continuation of their efforts, increase of their fee, and adoption of the one-year extension of the agreement.

The proposed fee structure is similar to that of the predecessor agreement, i.e., base payments plus an increase for CPI.

POLICY

REFERENCE: 2003 General Plan; 2006 Economic Development Strategy.

FISCAL

IMPACT: From FY 2006 payment of \$78,100 to a proposed \$82,000 for FY 07. The proposed

payments are included in the adopted 4-year Financial Plan.

OPTIONS: A. Approve, and Authorize the Mayor to Execute, the Agreement.

B. Amend, Modify or Reject the Agreement.

Thank you for preparing and presenting the Main Street Association proposal to continue downtown business promotion and historic preservation services during Fiscal Year 2006/07.

The Paso Robles Main Street Association has been an important contributor to the City's effort to promote downtown businesses and historic preservation. A strong, successful and historic downtown continues to be an important factor in the City's economic vitality, thus continuation of your services is also important. Concurrently, and looking forward, the 2006 Economic Strategy includes other high priority economic development objectives that will be considered for funding by the City Council in the Spring. It seems appropriate, therefore, to continue discussions concerning long-term economic development needs through the same time period.

To this end, the City Council's ad hoc committee (Council Members Gary Nemeth & Fred Strong) will be recommending to the City Council that City and Main Street economic development discussions, and the current contract, continue through June 30, 2007. Specifically, they will recommend that the base contract commitment of \$78,100 be adjusted for inflation to recognize cost increases. The proposed revision will provide a new rate totaling \$82,000 for the twelve months July 1, 2006 – June 30, 2007.

Your comments regarding this recommendation are welcome. The matter will be scheduled for formal consideration by the City Council in October 2006.
