1. Results of Consolidated General Election - November 7, 2006

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Heggarty, seconded by Councilmember Strong, moved to adopt Resolution No.06-225 reciting the facts of the Consolidated General Election held on November 7, 2006: Frank R. Mecham was elected as Mayor for the full term of two (2) years; John R. Hamon, Jr. was elected as Member of the City Council for the full term of four (4) years; and Duane J. Picanco was elected as Member of the City Council for the full term of four (4) years.

Motion passed by the following unanimous roll call vote:

NOES: ABSTAIN: ABSENT: The City Council members recognized outgoing Mayor Pro Tem Jim Heggarty for his distinguished service to the community of Paso Robles and for the straightforward and sincere manner in which he has carried out the responsibilities and duties of his office.

2. Oaths of Office and Seating of Newly Elected Mayor and Councilmembers D. Fansler, City Clerk

Oaths of Office were administered to members of the new Council: Mayor Frank Mecham and Councilmembers John Hamon and Duane Picanco.

Council adjourned for a 20-minute recess, and the public was invited to share refreshments and take this opportunity to extend their farewells to outgoing Councilmember Heggarty.

Council reconvened at 8:00 PM. with the Mayor and all City Councilmembers present.

3. Selection of Mayor Pro Tem, Redevelopment Agency Chairman, and Redevelopment Agency Vice Chairman

F. Mecham, Mayor

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Hamon, seconded by Councilmember Strong, moved to appoint Councilmember Nemeth as Mayor Pro Tem. Motion passed by unanimous voice vote.

Councilmember Nemeth, seconded by Councilmember Hamon, moved to appoint Councilmember Strong as Redevelopment Agency Chairman. Motion passed by unanimous voice vote.

Councilmember Strong, seconded by Councilmember Nemeth, moved to appoint Councilmember Hamon as Vice Chairman of the Redevelopment Agency. Motion passed by unanimous voice vote.

4. Appointment of Members to Council Liaison and Ad Hoc Committees F. Mecham, Mayor

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Picanco, seconded by Councilmember Nemeth, moved to continue the item. Motion passed by unanimous voice vote.

Appeal of Planning Commission Approval of Tract 2772 (Erskine)

Consider an appeal of Planning Commission approval of Tract 2772, an industrial subdivision involving 36 lots on 39 acres, located along Dry Creek Road, west of Airport Road. The appeal is filed by Tom Erskine, a neighboring property owner, citing concerns with traffic safety and use of private streets to access his adjoining property.

Mayor Mecham opened the public hearing. Mr. Erskine reviewed his appeal with the Council; and applicant Chris Hoskins and Andrew Hays, attorney for the applicant, outlined the Tract 2772 project. There were no further comments from the public, either written or oral, and the public discussion was closed. Councilmembers Picanco, Strong and Nemeth each declared they had separate *ex parte* meetings with Doug Mondo, an applicant of the project.

Councilmember Strong, seconded by Councilmember Nemeth, moved adopt Resolution No. 06-226 approving the appellant's request to amend approval of Tentative Tract 2772, amending Condition No. 24 as follows: "The applicant shall design a public street from Dry Creek Road through the subdivision to the boundary of APN: 025-431-040 subject to the approval of the City Engineer. The public street shall be offered for dedication on the final map."

The Subdivider, John Bertoni, has constructed Country View Lane (located along 21st Street, west of Almond Springs Drive), in Tract 2521, in accordance with the Subdivision Improvement Agreement approved on June 7, 2005. Following a one-year period, the City will assume street, sewer and drainage maintenance costs. Parkway landscaping and street lighting costs will be financed by the benefiting property owners through the Landscape and Lighting District.
- 10. Adopt Resolution No. 06-228 accepting the completed public improvements of Tract 2775 into the City's maintenance system. The Subdivider, James Guthrie, has constructed Maplewood Court (located along Maple Street, south of Pacific Avenue), in Tract 2775, in accordance with the Subdivision Improvement Agreement approved on June 20, 2006.

The purpose of the request is to expand residential use of the adjacent parcel to the abandoned area. The Planning Commission recommended approval of the request.
