Ms. Rochez will need pictures of the proposed site and approval from the city as they prepare their essay for an opportunity to win \$300,000 of Boundless Playground equipment through a grant.
- Doug Monn, Director of Public Works, has been checking on possible park sites and the choices are: Turtle Creek, Pioneer Park, or Montebello Oaks (off Union Road).
- Staff discussed City Council policy not to add anything to the Master Plan, city parks, moratorium, etc.
- Director Robb suggested the Advisory Committee move forward with their recommendation, ideally at Pioneer Park. City staff, Rob Nash, and Nikol Rochez could

- meet and look for a location at Pioneer Park for the playground. Staff needs to do a staff report to get on the first or second City Council agenda in order to meet the December grant deadline. Monn advised City Council will need a cost estimate on this project.
- A motion was made by Member Gibson, seconded by O'Farrell, to make a recommendation to preferably use Pioneer Park, or Turtle Creek, for a minimum of 7500 square foot required for a Boundless Playground in the city motion passed.
