- 5. <u>Receive and file Advisory Body Committee minutes as follows:</u> Senior Citizen Advisory Committee meeting of March 12, 2007
- **6.** Proclamation designating May 2007 as Paso Robles Wine Month. In 2007, the Paso Robles Wine County Alliance will celebrate the 25th Anniversary of the Paso Robles Wine Festival, to be held May 18-19 and 20. Paso Robles' wine grape growing and production is a significant agriculture industry with over 26,000 vineyard acres contributing an estimated annual impact of over \$1.6 billion to the San Luis Obispo County economy.
- 7. Approve a Special Events request from the North County Cloud Clippers (a local radio controlled model aircraft club) to utilize a portion of the Municipal Airport to host an open house/air meet *Airport Day 2007* on Saturday, September 15, 2007. The Airport hosts a number of aviation fly-ins and special events each year as part of its on-going promotional effort. The Citizens' Airport Advisory Committee reviewed the request from the Cloud Clippers at their March 22 meeting and recommends approving the request.

The Planning Commission tentatively approved the Parcel Map on October 12, 2004; all conditions imposed have been satisfied (applicant: Michael Faherty).
- **12.** Adopt Resolution 07-044 accepting the Parcel Map PR 06-0049 for recordation, a three-lot commercial subdivision located at 2901 Riverside Avenue. The Parcel Map was tentatively approved by the Planning Commission on July 11, 2006; all conditions imposed have been satisfied (applicant: Larrache Land Company)
