**SUBJECT:** Edward Byrne Memorial Justice Assistance Grant Program (Number 16.738)  
**DATE:** September 4, 2007

**NEEDS:** For the City Council to consider accepting approximately \$12,500 in FY 2008 from the Edward Byrne Memorial Justice Assistance Grant Program.

**FACTS:**

1. The City of Paso Robles Is eligible to receive approximately \$12,500 in FY 2008 from the Edward Byrne Memorial Justice Assistance Grant Program.
2. These are “entitlement” funds and do not require matching funds from the City’s budget.
3. The grant does require a public hearing for Council notification and public comment regarding the proposed use of the grant funds by the Police Department prior to the dispersal of funds. This will be accomplished during the regularly scheduled Council meeting during their review of this staff report, where public comment will be invited.
4. The Police Department intend to use the Edward Byrne Memorial Justice Assistance Grant funds to purchase new AR-15 rifles and accessories to replace old, antiquated rifles in its patrol fleet. The budget for this program will allow for 6 new rifles to be installed in over half of the current patrol fleet.

**ANALYSIS &  
CONCLUSION:**

The Police Department currently deploys some AR-15 rifles in a small percentage of its patrol fleet. These rifles were provided to the Department as used weapons by the California Department of Corrections approximately 7 years ago, and they are estimated to be over 25 years old. They are worn and antiquated. The firepower in the hands of criminals today demands that law enforcement officers are equipped to properly respond to a high-power rifle threat. The Police Department intends to use the Edward Byrne Memorial Justice Assistance Grant funds to purchase new AR-15 rifles and related accessories to replace old rifles in over half of our patrol fleet.

The expenditure plan is detailed in attachment “A” with minor variances in final procurement decisions being allowable by grant rules based on identified need. The Police Department will cover minor overage costs above the allotted \$12,500 grant funds.

WHEREAS, the City of El Paso de Robles Police Department is eligible for funds up to \$12,500.00 from the Edward Byrne Memorial Justice Assistance Grant Program (Number 16.738); and

WHEREAS, the Edward Byrne Memorial Justice Assistance Grant Program has notified the City of a \$12,500.00 maximum award to be received by the City of El Paso de Robles in fiscal year 2008; and

WHEREAS, the monies received from the Edward Byrne Memorial Justice Assistance Grant Program are for the purpose of budgeting personnel, programs and/or equipment; and

WHEREAS, with the acceptance of the above described Edward Byrne Memorial Justice Assistance Grant Program funds, the police department plans to purchase a variety of equipment for the police department's patrol fleet, to support the frontline law enforcement mission.
