Needs: That the City Council rescind Final Map approval of Parcel Map PR 06-0012

(Stoll).

Facts:

1. At their meeting of September 4, 2007, the City Council accepted Parcel Map PR 06-0012 for recordation. Parcel Map PR 06-0012 is a two-lot subdivision located at 1810 Park Street.

- 2. As a condition of approval of Parcel Map PR 06-0012, alley paving is required. Mr. Stoll agreed to post a bond in the amount of \$15,000 to guarantee his performance. As of the date of this report, the bond has not been received by the City. Therefore, the map has not been sent to the County Recorder's office.
- 3. Subdivision Map Act Section 66466 requires that the City Clerk place the map on the agenda of the next regular meeting of the City Council and rescind its approval.

Analysis and Conclusion:

Parcel Map PR 06-0012 was tentatively approved by the Planning Commission on June 13, 2006. Conditions imposed by the Planning Commission have been satisfied with the exception of alley paving.

Mr. Stoll agreed to post a bond in the amount of \$15,000 to guarantee the completion of alley paving. Based upon the agreement, a staff report was prepared and the map was scheduled for City Council acceptance on the consent calendar at its meeting of September 4. To date, no bond has been submitted.

If the map approval is rescinded, the applicant will retain Planning Commission approval of the tentative map and will continue to have the opportunity to post the bond and to request council acceptance of the map for recordation.




