CITY COMMUNICATION/REPORTS

- Lynda Holt, Recreation Coordinator, gave an update on trips and all the events listed in the monthly Senior Citizen newsletter. Lynda needs volunteers to help work two hour shifts at the Senior Health Fair to be held at Twin Cities Hospital.
- Charlotte Gorton, Recreation Services Manager, discussed there is a Universal Studio Halloween trip for teens, Creek Day was Saturday, September 29 with 60 participants cleaning up the Salinas River-bed, College 101 Workshop for teens was Saturday, September 15 with 120 participants, and the Thanksgiving dinner will be at Centennial Park again this year.

• Annie Robb, Director, thanked all for working on Black Tie Bingo that was very successful. She also mentioned city water rates, Mike Compton, Director of Administrative Services, retired, and his replacement, Jim Throop, will report to work soon. The recreation division is doing very well with fall programming.

- Member Pluma cautioned members about parking in/near handicap spaces.
- Member Gruner handed out a Black Tie Bingo financial update. After we receive one more check, we should have raised \$5877.44 for the Senior Endowment Fund. Gruner asked members to keep in mind Senior Volunteer Services does not meet until January 2008. Therefore, we will not be able to get check cut to deposit into the Senior Endowment Fund until 2008.
