8. Water Rate Study

The City Council considered contracting with T. J. Cross Engineers, Inc., and Kennedy/Jenks Consultants to perform a "water needs" assessment and rate study.

Mayor Pro Tem Nemeth opened the public hearing. Speaking from the public was John Borst, Tom Hardwick, Kathy Barnett, Jerry Greene and Tom Rousch. There were no further comments from the public, either written or oral, and the public discussion was closed.

Councilmember Strong, seconded by Councilmember Picanco, moved to adopt Resolution No. 08-004 appropriating up to \$83,800 from Water Enterprise Funds to perform a water user rate study and authorizing the City Manager to enter into contractual arrangements with Kennedy/Jenks Consultants and T. J. Cross Engineers;

9. Root Control for Sewer Collection System

The City Council considered the purchase of root control equipment and chemicals for ongoing maintenance of sewer collection system. Katie DiSimone, Utilities Manager, presented the staff report.

Councilmember Hamon, seconded by Councilmember Strong, moved to adopt Resolution No. 08-005 authorizing the purchase of root control equipment and chemicals to perform sewer collection system maintenance in the amount of \$33,165;



Questions for P. R. City Council on the NWP from Jerry Greene,1639 Summer Creek Ln., P. R., CA15 January 2008

- 1. Thank you for wisely deciding to perform a rate study.
- 2. When the study is complete how will the funds be collected? Assessment, etc.?
- 3. Exactly how & why were T.J. Cross Engineers & Kennedy/Jenks Consultants selected as the <u>sole</u> study companies? Is competitive bidding required of the city? Since they are currently working on the NWP for the city isn't this a conflict of interest? Why was the list of study consultants submitted by John Borst not considered?
- 4. Where are all the NWP funds that have been collected to date (\$2.9 million)? In a restricted trust account? What has been dispersed?
- 5. No ordinance currently exists to collect NWP funds unless 882 is still in effect which is not clear. Is this unauthorized collection? Ordinance 882 calls for a 2-month billing cycle but we have a 1-month. What authorized this collection which increased city funds?
- 6. Is the city going to pay \$4/unit for the schools & city water used? Will this come from the city general fund & is it budgeted?
- 7. Will the NWP collection fees increase in Feb 08 instead of Jul 08 as scheduled?
- 8. Why does the Templeton Community Services District pay no NWP fees now or in the future?
- 9. Orange County in CA treats their sewer/waste water to produce clean drinking water. Our River Oaks local project is using this approach also. Why was this method not considered instead of the NWP?
- 10. Was Prop 218 considered when the high sewer fees were imposed and subsequently increased?
