## 1. 2008 Community Development Block Grant (CDBG) Program <br> R. Whisenand, Community Development Director

The City Council conducted a noticed public hearing and discussed which activities are to be approved for funding with the City's 2008 Community Development Block Grant ("CDBG") funds. Ed Gallagher, City Planner presented the staff report, noting that the County advised the City of a $\$ 17$ reduction in funding, since publication of the agenda
