SUBJECT: Code Enforcement Priorities

DATE: March 4, 2008

Needs:

For the City Council to review current code enforcement responsibilities and establish priorities for addressing and enforcing code violations in the City of Paso Robles.

Facts:

- 1. The City of Paso Robles Code Enforcement Program consists of two (2) full time equivalent positions, two (2) part-time and one (1) full-time, working primarily Monday through Friday.
- 2. Calls for service and enforcement efforts typically include private property blight (approximately 55%), vehicle violations (i.e.; vehicles on lawns; abandoned, overtime parking, etc. 32%), and other miscellaneous code violations (i.e. illegal signs, business licenses, noise, etc. -13%). See attachment "A" for detail.
- 3. CE Specialists have approximately 65 hours of time per week to accomplish investigation and enforcement activities on all calls received and self-initiated cases. See attachment "B" for time breakdown of current enforcement efforts.
- 4. It is necessary for the success of the Code Enforcement program to have enforcement activities prioritized so the CE Specialists focus their efforts on enforcement of those issues of greatest concern to the community. See attachment "C" for use in prioritizing CE enforcement activities.

Analysis & Conclusion:

The Police Department needs direction from the City Council regarding priority concerns relative to enforcement of code violations in the City of Paso Robles. With limited resources and a myriad of violations to address, it is important to prioritize the work of our personnel. By way of attachments, a listing of the most commonly observed and referred complaints are submitted for review. A rough analysis of time spent by Code Enforcement staff on these problems is also shown to give an idea of problem scope associated with each category. The final attachment provides a mechanism for the Council to provide direction regarding which categories should be considered top priority by policy. Code Enforcement staff will restructure their enforcement approach based on this input.

CITY OF PASO ROBLES - CODE ENFORCEMENT

The City of Paso Robles Code Enforcement Program consists of two (2) full time equivalent positions - two (2) part-time, and one full-time enforcement specialists, working primarily Monday through Friday.

Each specialist is assigned a geographical area of responsibility, patrolling and handling calls for service. Calls / enforcement efforts typically include private property blight (approximately 55%), vehicles (i.e.; vehicles parked on a lawn, overtime parking, abandoned vehicles etc. - 32%), and miscellaneous (i.e. illegal signs, business licenses, noise, etc. -13%).

<u>Blight</u>

The vast majority of private property violations are located on residential properties (97%). The remainder concern commercial, industrial and manufacturing properties. Typical complaints include:

Trash & debris
Vacant buildings
Attractive nuisances
Abandoned furniture and appliances
Unsafe / unpermitted building or structure
Extended storage/accumulation of dirt or like materials
Overgrown, dead, decayed, diseased or hazardous vegetation*
Erosion, subsidence, water drainage problems, or stagnant water

Most inspected properties have one or more of these violations.

* Emergency Services will continue to handle the Weed Abatement Program with assistance from Code Enforcement, if needed. Specialists will address weed issues on property that have violations starting in April of each year.

Vehicles

Vehicle violations are found on both private property and the public streets. Violations regularly include:

Overtime parking
Living in recreational vehicle
Vehicles parked on unpaved surfaces
Hazardous conditions involving vehicles
Abandoned and / or inoperative vehicles
Unregistered vehicles (parked on roadway)

Enforcement actions often include citations and towing of vehicles.

Miscellaneous

A variety of other code violations are also attended to, both in response to complaints and proactive patrol by the Code Enforcement Specialists. Examples of these calls for service are:

Noise

Sewage problems

Animal complaints

Illegal signs and banners*

No trash pick-up service

Illegal dumping (trash or haz-mat)

Street furniture violation (i.e. basketball hoops)

Smoking in restricted areas (business establishments)

Business license violations (no license / operating out of compliance)

* Code Enforcement and the Planning Division have developed a Sign program to address illegal

A-frame signs and banners across the city. This is primarily self-initiated work by the CE specialists through regular beat patrols.

Summary

With the Code Enforcement division fully staffed, net hours spent on addressing code related issues will be approximately 65 hours per week (accounting for mandatory breaks, vacation, training time, etc.).

Attached is a Code Enforcement Activity Matrix listing common violations and enforcement action time requirements. The City Council should use this worksheet to prioritize enforcement efforts.
