SUBJECT: RIVERSIDE AVENUE LIGHTED CROSSWALK (DPW 08-09): AWARD OF BID

DATE: APRIL 1, 2008

Needs: For the City Council to consider awarding the contract to construct a crosswalk in Riverside

Avenue at the main entrance to the Paso Robles Event Center which will include LED lights,

colored and scored concrete, and two new handicapped ramps.

1. On November 6, 2007, the City Council adopted Resolution 07-219, which appropriated a total of \$183,700 in Workforce Housing Reward Grant (WFHR) funds to construct sidewalks and related street improvements along the frontage of the Paso Robles Event Center Parking Lot.

2. \$125,000 of the \$183,700 were 2004 WFHR funds, which must be requested from the state by April 30, 2008 or be forfeited. State regulations governing the WFHR funds allow the funds to be used for design of public facilities but also require that a public facility must be constructed with the funds. WFHR funds cannot be requested unless a contract has been awarded and construction commenced.

- 3. The Lighted Crosswalk project is a subset of the larger project, which will include installation of sidewalks, street lights, street trees, and other improvements along the west side of Riverside Avenue between 21st and 24th Streets and along the south side of 24th Street, along the Event Center frontage. The entire project will be designed to be accomplished in phases that will accommodate available funding.
- 4. On March 20, bids for the lighted crosswalk project were opened. The City received four bids. The lowest responsive and responsible bid was submitted by Newton Construction & Management in the amount of \$54,525. A Bid Summary is attached.

Analysis and Conclusion:

Facts:

Newton Construction & Management's bid is complete, responsive, and responsible. The \$54,525 price is below the cost estimate, which was \$90,300, but within the project budget. An adequate amount of Workforce Housing Reward Grant funds has been budgeted to cover the contract costs and for any contingencies that may arise. Any unused funds could be reprogrammed for other Workforce Housing funds-eligible projects.
