The City Council held a Public Hearing to receive public testimony regarding the annual levy of the Landscape and Lighting District No. 1, and adopt resolutions to order the collection of assessments for Fiscal Year 2008-2009. Dennis Fansler presented the staff report.

## DISCUSSION

Councilmember Picanco recused himself from discussion of Item No. 11 due to family members residing in the area under consideration and left the dais.

### 11. Sand Mine Applications in the North County

R. Whisenand, Community Development Director

The City Council considered mitigation of impacts on City streets resulting from sand mine operations in the unincorporated area of the North County. (Continued from May 20, 2008). John Falkenstien presented the staff report.

Mayor Mecham opened the public hearing. Speaking from the public was John Beale, Ole Viborg, Joe Plummer, David LaRue, Patty Davis, Debra Compton. There were no further comments from the public, either written or oral, and the public discussion was closed.

Councilmember Nemeth, seconded by Councilmember Hamon, moved to direct staff to write a letter to the County Planning Department, copy to County Public Works Department, requesting that they include conditions of approval of any sand mine permit contributing truck traffic to Airport Road to:

1. enter into a road maintenance agreement with the City to provide funding to maintain Airport Road paving in accordance with the City's Pavement Management Program from Highway 46 to Tower Road; and
2. to contribute one-tenth of one percent of the estimated cost of Airport Road-Highway 46E improvements for every 10 average daily trips projected by the application.

**12. Sodium Hypochlorite Facility at Wastewater Treatment Plant**

The City Council awarded a construction management services contract for construction of a sodium hypochlorite facility at the Wastewater Treatment Plant.

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Hamon, seconded by Councilmember Nemeth, moved to award the construction oversight contract to install a new sodium hypochlorite facility at the Wastewater Treatment Plant to ATS, Inc. for a not-to-exceed amount of \$97,775.

Gentlemen,

Good evening. In reading over the Urban Water Management Plan discussed at the June 3 City Council Meeting I would like to suggest the following change/addition be made on page 14 of the document.

At the bottom of page 14 it currently reads:

"Execution of the Paso Robles Groundwater Basin Agreement and initiation of cooperative groundwater monitoring and management reduces the likelihood of overdraft and water rights disputes and promotes the long-term reliability of groundwater supplies."

I would like to see the below statement of case law directly follow the above quoted sentence:

**Each overlying owner in the Groundwater Basin has a correlative right to available water: "if the quantity is insufficient, each overlying owner is limited to his proportionate fair share of the total amount available based upon his reasonable need. (*Tehachapi-Cummings County Water Dist. v. Armstrong, supra*, 49 Cal.App.3d 992, 1001.)"**

I believe adding such a statement is consistent with the City water resource goal of "maintain strong water rights position," and clarifies to the public the City's Groundwater Basin water right under current law.
