# 1. Advisory Body Interviews & Appointments to the Housing Authority of Paso Robles Board of Commissioners

The Project Area Committee (PAC) is an advisory body to the Paso Robles Redevelopment Agency, City Council and, depending upon the specific topic, project or program, the City's Planning Commission. The PAC's mission is to formulate recommendations from property owners, business owners, and other persons with interests in the approximate 1150-acre Paso Robles Redevelopment Project Area.
