SUBJECT: Resolution for State Revolving Loan Fund

DATE: October 7, 2008

NEEDS:

For the City Council to consider adopting a resolution from the State Revolving Loan Fund authorizing the City Public Works Director to act as the City's agent in discussions with the State regarding possible future financial assistance applications.

FACTS:

- The City is conducting a feasibility study to determine the most effective manner to address regulatory requirements of the City's National Pollutant Discharge Elimination System (NPDES) permit.
- The feasibility process will be completed in 2009.
- As part of the feasibility study, potential financing instruments to fund implementation of study findings are being explored.
- 4. One financing instrument is the State Infrastructure Revolving Loan Fund Program. Loan can be requested for 85% to 100% of waste water discharge project construction cost.
- To open discussions, the City Council is requested to adopt a resolution from the loan fund program expressing interest in the program and assigning a contact individual. Adoption of the resolution does not constitute a contract with the State, nor does it result in any cost to the City (other than staff time).

ANALYSIS &

CONCLUSION: The Regional Water Quality Control Board has informed the City of the need to improve quality of discharge associated with its NRDES permit. To this end, the City has contracted with the engineering firm of Black and Veatch to complete a feasibility study to outline methods to be used to accomplish the task.

IMPACT: Adoption of the attached resolution would not result in any impact to the City or its

Waste Water Funds. It would allow staff to open discussion with the State regarding the possibility of securing a low interest loan for future waste water infrastructure.

WHEREAS, the <u>The City of Paso Robles</u> (the "Agency") desires to finance the costs of constructing and/or reconstructing certain public facilities and improvements relating to its water and wastewater system, including certain treatment facilities, pipelines and other infrastructure (the "Project"); and

WHEREAS, the Agency intends to finance the construction and/or reconstruction of the Project or portions of the Project with moneys ("Project Funds") provided by the State of California, acting by and through the State Water Resources Control Board (State Water Board); and

WHEREAS, the State Water Board may fund the Project Funds with proceeds from the sale of obligations the interest upon which is excluded from gross income for federal income tax purposes (the "Obligations"), and

WHEREAS, prior to either the issuance of the Obligations or the approval by the State Water Board of the Project Funds the Agency desires to incur certain capital expenditures (the "Expenditures") with respect to the Project from available moneys of the Agency; and

WHEREAS, the Agency has determined that those moneys to be advanced on and after the date hereof to pay the Expenditures are available only for a temporary period and it is necessary to reimburse the Agency for the Expenditures from the proceeds of the Obligations.

THEREFORE BE IT HEREBY RESOLVED by the City Council of the City of El Paso de Robles to allow the City Public Works Director to act as the City's agent and sign a Financial Assistance Application to open discussions with the State Revolving Loan Fund Program regarding a potential Waste Water Treatment Plant rehabilitation.
