**NEEDS:** For the City Council to consider accepting up to \$100,000 from the California State Supplemental Law Enforcement Service Fund (SLESF) and to consider approving an

associated expenditure plan for all SLESF monies.

1. The City of Paso Robles continues to receive up to \$100,000 from the California State Supplemental Law Enforcement Services Fund (SLESF) each fiscal year. This money has been spent on miscellaneous front line law enforcement equipment.

- **2.** During fiscal year 2009, it is anticipated that the City of Paso Robles will again receive up to \$100,000 from the California State Supplemental Law Enforcement Services Fund. The funding will be distributed by the State on quarterly basis with a possible mid-term review to cease funding if necessary.
- **3.** Existing law requires the County Auditor to allocate all monies received from the Supplemental Law Enforcement Services Fund (SLESF) within 30 days of deposit of those monies. A modification to this law requires that before the County Auditor can disperse these funds, a copy of an approved expenditure plan from each City Council or Board of Supervisors be submitted to the Supplemental Law Enforcement Service Fund Oversight Committee for review and certification.
- **4.** With receipt of the FY 2009 SLESF funding, the City will have just over \$282,000 set aside to finish a Mobile Data Computer (MDC) project and purchase other equipment.
- 5. New funds received this fiscal year will be in addition to the funds already set aside to complete the MDC project. We expect to spend the new monies on miscellaneous frontline law enforcement equipment needs. See attached spending plan. (Attachment "A")
- **6.** A noticed public hearing must be held with public comment allowed, either written or oral, regarding the proposed use of these grant funds. This will be accomplished at the regularly scheduled City Council meeting during their review of this staff report. Public comment will be invited.

# ANALYSIS & CONCLUSION:

**FACTS:** 

The Paso Robles Police Department will accumulate just over \$282,000 in funds from the California State Supplemental Law Enforcement Service Funds (SLESF) should we receive the entire \$100,000 this fiscal year. These monies will be used to complete the Mobile Data Computer (MDC) project by adding 54ward voice recognition software to allow MDC use through voice command to enhance efficiency, safety and reduce the amount of multitasking for officers as they operate the patrol units and various equipment simultaneously. The remaining funds will be used for other miscellaneous equipment needs (See Attachment "A").

Two items on the list will require commitment of future funds in order to maintain the new equipment. The 54ward systems require maintenance agreements in the amount of \$399.00

per unit per year, totaling \$4,800 annually. There are sufficient funds in the SLESF account to cover this cost through FY2010 whether or not SLESF funding continues annually. The additional computer monitors would normally be added to the equipment replacement fund in the amount of 1,200 per year. These additional screens would be considered for replacement by future grant funding unless added to the equipment replacement fund in a future budget process.

The State of California has only committed 25% of the \$100,000 to be deposited quarterly, beginning retroactively to July 1, 2008. The Police Department will make equipment purchases as funds are deposited. Where listed items exceed the amount of a quarterly deposit, funds will be held until satisfactory deposits have been received to cover the entire cost of an item before the purchase is authorized.

FISCAL IMPACT:

Up to \$100,000 to fund #117-210-5235-136 for expenditures on miscellaneous front line law enforcement equipment for the Paso Robles Police Department as identified in "Attachment A."

Potential recurring cost to General Fund of \$6,000 annually to be considered after FY2010.

- **a.** Adopt Resolution No. 08-xx accepting the California State Supplemental Law Enforcement Service funds available in fiscal year 2008/09 and approving the outlined expenditure plan.
