Board Meeting Minutes

Call to Order: The regular monthly meeting of the Museum's 501(c) (3) corporation board members was called to order by B.R. "Bob" Bryant, at 4:00 p.m. at the museum, 2010 Riverside Avenue, Paso Robles.

Report on D& O Insurance

Ben Holsted presentation on Directors and Officers Insurance. D & O insurance protects form claims for wrongful acts, there is no bodily injury or property damage coverage on a D & O policy. It does cover allegations of rulebook violations or Bylaw infractions as it pertains to an organization's membership. Typically, these claims arise when members of an organization become upset by some decision made by the Board. The member(s) hire a lawyer and claim that they were wronged in some fashion. This is what the D& O insurance covers. D & O insurance is considered "piece of mind" insurance- protected the board from such claims of wrongful acts. Wrongful acts means any actual or alleged act, error, omission, miastatement, misleading statement, neglect, or breach of duties, or Personal Injury Act committed;

By the organization, by the individuals Insureds arising solely from duties conducted on behalf of the Organization or asserted against an Individual Insured because of the Organization.

Limit of the liability is normally \$1 Million.

Pioneer Day Committee has this insurance.

Discussion from the group the Paso Gathering may need this coverage if they were to reject someone from having a booth at the Gathering. Also, if someone were to donate an object to the museum and the family comes back later and asks for the item back. If the Board say's "no" ... could this become a D & O claim? Ben says "it could be."

Bob Tullock suggests the Board fill out the paperwork and get a quote.

Cost of the insurance is expected to be \$1,000 per year or less. But the only way to know for sure is to fill out the paperwork (one page) and submit it for the quote.

Bob Bryant asked if the policy would cover the group as a trustee for the City Museum or only when we are acting as the 501(c)(3)?

Ben says that as long as the group is acting as a Board.

Bob Bryant thanks Ben for coming and accepts the copy of the paperwork to get the quote.

Report on Visit to Fisher Residence in Creston and offer of assistance with fundraising project

ByBy reported on a meeting that she and Bob Bryant had with Todd Fisher. They were invited out to the Fisher's Creston home to see the costumes and other memorabilia that he is storing for a museum to be constructed in Tennessee. Fisher is a son of Debbie Reynolds, and has been collecting for many years. Some of the more notable items include the red sports car driven by Marilyn Monroe in "Some Like it Hot" also in the collection is all the captains costumes for the different remakes of the "Mutiny on the Bounty" and other items too numerous to mention. Fisher has offered to loan some of these items to the Pioneer Museum and including his expertise in set up and lighting if the Museum wants to hold a limited fundraising such as a cocktail party or other. Along with the memorabilia collections, Fisher also has a production set up which he offered to help the Museum create multimedia kiosks for some of the displays. He also indicated that he has connections with many production equipment manufacturers such as Panasonic and Sony that occasionally donated used studio equipment to various non-profits. Bob Bryant would like to see the Museum create a video of the blacksmith shop and a demonstration of the various equipment pieces they are looking at in the collection. Bonnie suggested that Karl Von Dollan and Harold Franklin would be good candidates to work on such a project. ByBy reminds all that Fisher offered to help with fundraising event and it will need to be done before the entire collection heads to it's new location so we need to look at early next year at the latest. Bob Tullock says remember that when Marilyn Monroe and Joe DiMaggio were married they spent a night in the Paso Robles Inn. Bob Bryant says more than that- many celebrities came up to entertain troops at Camp Roberts so there are even more connections.

Councilman Strong says that if we do decide to go with the cocktail party fundraising event that the Museum should consider getting a temporary liability insurance policy to cover the event.

Anyone interested in the cocktail party idea needs to get in touch with ByBy.

Milene shows off the Current issue of CCM, which includes a borrowed photo from the Museum and lists the Pioneer Museum as the source.

Milene also talked about the CCPH the history group which held the annual meeting in SLO and visited several areas in the County including the Pioneer Museum.

Bob T reports on a letter from the Main St. Christmas Parade group which include invitation to Pioneer Museum, Jeansville Pump, Pioneer Day Committee and Historical Society to participate in the parade.

Bob Bryant reads a letter he is sending to KPRL thanking them for support to the Paso Gathering and the Pioneer Museum. Bob says he will send this letter to KPRL if there are no objections from the Board. Board has no objection.

Financials: Financial Report is down. The endowment fund is down a fair amount due to the depressed stock market. Bonnie reports that part of the down trend may be that the Paso Gathering income is not reflected in this financial statement, but the expenses are.

Call for presentation of bills: Several bills are submitted for payment. Included in those submitted were bills to continue the drainage and the preparation for paying projects on the grounds, sand, underground boxes to channel water, and bulbs for interior light replacement. Other bills were presented for Blakes for casters and other hardware for the display cases, and reimbursement for paper cups purchased by docent for museum. Additional bills were presented for various office and display needs such as outdoor bench repairs, labels for the wagon tongues. Milene asks if someone paid AT & T to install the phone in the shop area of the Museum and was told that this was a donation by Chuck (?)

Moving Farm equipment to Store Between Ballfield and Museum

been suggested that the Museum store some of the farm equipment against the side of the Museum building by the ballfield. It used to be a picnic area but it has been fenced off so there is no longer access. It would be ideal to store some farm equipment there alongside the building and it would help to keep the weeds down in the area and reduce the City's expense for upkeep of that area. Bob B says he approached the City to ask and was told that it would have to wait until the Master Plan was complete and the representative of the City was not sure who had the authority to grant the request.

Councilman Strong suggests that the Museum approach the City Council during a public comment period and ask place this item on a future city council agenda. Emphasis should be placed on the idea that this is temporary and that it doesn't impact the City plan and it would reduce City costs. Board agrees with Bob B to approach the City.

Recent DWR Local Groundwater Assistance Grant Awards

Thank you for your interest in the Local Groundwater Assistance (LGA) AB 303 Program in applying for a grant in December 2007. We had a record number of 122 grant applications. In June 2008 after an extensive DWR review, the LGA Technical Advisory Panel (TAP) in a public meeting recommended awarding thirty (31) public agencies grants using Proposition 50 funds. Due to the number of additional qualified applications, they also recommended funding additional applications in the next Fiscal Year.

In late September, the Governor signed legislation (SBx2 1) that allocated additional funding for the Program (see http://gov.ca.gov/press-release/10690/). These funds will not be available until March 2009. Based on the recommendations of the TAP, DWR awarded grants using Proposition 84 funds to agencies from the 2007 applications that scored from 84 to 87 points. Two other agencies, Lassen and Amador Counties, were awarded funding based on geographic considerations. The 25 public agencies who are receiving grants include six (6) that were partially funded in June 2008 and are now funded to meet their original requests; sixteen (16) received full funding; and three (3) received Capacity Building Grants for \$50,000 each. In total 50 local agencies received grants from both funding sources. A listing of the agencies and title of projects receiving grants may be obtained through the Division of Planning and Local Assistance website at: http://www.grantsloans.water.ca.gov/grants/assistance.cfm

No further awards are expected from the December 2007 applications. Therefore, this email is also to thank those agencies who applied but did not receive funding. Funding has also been appropriated for another round of LGA grants. A proposal and solicitation package (PSP) is expected to be released in the Spring/Summer of 2009, with approximately 6 to 8 weeks to complete the applications. Any proposed changes to the PSP will be

discussed in a TAP public meeting that is expected to occur early next year. Please check the above LGA web page for notification of the meeting and any other LGA announcements. Emails will also be sent out concerning the meeting.
