SUBJECT: Amend the City's Adopted Conflict of Interest Code

DATE: March 3, 2009

Needs:

For the City Council to consider amending the City's Conflict of Interest Code to include update categories of designated personnel required to file FPPC statements, and to modify Disclosure Categories to reflect current government regulations.

Facts:

- 1. The Political Reform Act of 1974 requires every local government agency to adopt and circulate a Conflict of Interest Code, and submit an amended Code in accordance with Fair Political Practices Commission Regulations.
- 2. The City Council last amended the Code by Resolution No. 08-002, on January 15, 2008.
- 3. This year, the list of designated personnel was fully revisited in the context of newly added positions and consideration of various areas of responsibility.

POLICY REFERENCE:

FPPC Reg. 18730 and Government Code Sections 81000, and 87302

FISCAL IMPACT:

There is no fiscal impact to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of El Paso de Robles hereby amends the City's Conflict of Interest Code as follows:

Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Executive Director's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code.

#### **EXHIBIT "B"**

## **DISCLOSURE CATEGORIES**

### Category 1

- (a) Interests in real property<sup>1</sup> which is located whole or in part (1) within the boundaries of the City of El Paso de Robles, or (2) within two miles of the boundaries of the City of El Paso de Robles, including any leasehold beneficial or ownership interest or option to acquire such interest in real property, if the fair market value of the interest is greater than \$2,000.
- (b) Investments<sup>2</sup> in or income<sup>3</sup> from business entities which are contractors or subcontractors which are or have been within the previous two-year period engaged in the performance of building construction or design within the City of El Paso de Robles.
- (c) Investments<sup>2</sup> in or income<sup>3</sup> from persons or business entities engaged in the acquisition or disposal of real property within the jurisdiction of the City of El Paso de Robles.

## **Category 2**

<u>Investments</u><sup>2</sup> in or <u>income</u><sup>3</sup> from business entities which manufacture or sell supplies, books, machinery, or equipment of the type utilized by the department for which the designated employee is Manager or Director. Investments include the interests described in Category 1.

## Category 3

<u>Investments</u><sup>2</sup> in or <u>income</u><sup>3</sup> from business entities which are contractors or subcontractors engaged in the performance of work or services of the type utilized by the department for which the designated employee is Manager or Director. Investments include the interests described in Category 1.

<sup>&</sup>lt;sup>1</sup> Interests in real property of an individual include a business entity's share of interests in real property of any business entity or trust in which the designated employee or his or here spouse owns, directly, indirectly, or beneficially, a ten percent interest or greater.

<sup>&</sup>lt;sup>2</sup> Investments include:

<sup>(1)</sup> Any financial interest in or security issued by a business entity, including but not limited to common stock, preferred stock, rights, warrants, options, debt instruments, and any partnership interest or other ownership interest;

<sup>(2)</sup> A pro rata share of investments of any business entity or trust in which the designated employee or his or her spouse owns, directly, indirectly, or beneficially, a ten percent interest or greater.

No source of income is reportable unless the income received by or promised to the public official aggregates \$500 in value during the preceding 12-month reporting period
