**WHEREAS**, the Sexual Assault Recovery and Prevention (SARP) Center first initiated services in 1976 for survivors of sexual violence by providing a 24 hour crisis line, accompaniment and advocacy; counseling services; and outreach services in schools and the community; and,

**WHEREAS**, the SARP Center works cooperatively with local law enforcement agencies, the District Attorney's Office, the Suspected Abuse Response Team, and other social services agencies in order to support survivors through the healing process; and,

**WHEREAS**, the SARP Center is a private non-profit agency supported through its partnership with local organizations, businesses and individuals who have contributed to the effort to end sexual violence; and,

**WHEREAS**, the SARP Center is committed to eliminating sexual violence through education and community action and promoting equality, safety, and respect among all individuals.
