- NEEDS: For the City Council to consider again hosting a North County Job Fair in collaboration with local industry partners.
- FACTS: 1. The City has collaborated with local industry partners to hold a North County Job Fair event at the City Hall Chamber conference center for the past three years. With over 25 businesses and several hundred jobseekers attending each year, the event has been deemed a success by partnering participants.
  - 2. As with last year, the main partner behind this event will be the Workforce Investment Board (WIB). The WIB is a State established Board whose purpose is to assist in setting and guiding policy in the area of workforce development. The WIB, in turn, targets funding resources to those industries whose missions support their priority policies (such as workforce training and life long learning).
  - 3. In addition to the WIB, the following agencies and businesses are participating as partners in this Job Fair event:
    - Employer Advisory Council (EAC)
    - Employment Development Department (EDD)
    - Cuesta College
  - 4. The purpose of the Job Fair is to connect job seekers with job providers within the community. Past years events have attracted exhibitors from a variety of industries including manufacturing, health care, banking, hospitality, construction, and public/institutional.
  - 5. In partnering with WIB on this event, the City would be lending its name to the promotion of the event, as well as providing one day use of the City Hall/Library conference facility on Tuesday, September 29<sup>th</sup>. City sponsorship will also provide the opportunity for scheduling use of the Spring Street banner space.
  - 6. City staff resources would be provided in the logistical planning and promotion of the event, working closely with WIB and other partners

to jointly meet the needs of the community's businesses and workforce. Resources would also be utilized in room set up the day of the event.

## ANALYSIS & CONCLUSION: The City's Economic Strategy supports the formation of public/private partnerships to foster support for Paso Robles business growth and A job fair endeavor, which is designed to meet the success. employment needs of the North County business community and work force, is an example of such a partnership. POLICY **REFERENCE**: Economic Strategy. FISCAL IMPACT: The "in-kind" contribution of facility rental and staffing is estimated to be under \$1,000.
