SUBJECT: Redevelopment Implementation Plan Amendment: Expand Scope of Implementation Projects
DATE: September 1, 2009

Needs: For the Redevelopment Agency to consider a proposal to amend the Redevelopment Implementation Plan to allow redevelopment funds to be used for the following activities:

- a. To provide assistance to the San Luis Obispo County Office of Education for the development of a center for childhood school readiness program and parent education, in conjunction with the First 5 Commission of San Luis Obispo County. The initial contribution of \$240,000 will come from funds held by the Agency in trust for COE facilities, and may include other future contributions.
- b. To supplement funds from the Federal Emergency Management Agency to remediate and repair the damage to the City Hall parking lot caused by the 2003 San Simeon earthquake. The estimated supplementary amount is \$300,000.
- c. To acquire property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park. The estimated cost of the Park restrooms is \$1.5 million; the estimated costs of other facilities is not presently known.

Facts:

1. Section 33490 of the California Health and Safety Code requires that each Redevelopment Agency adopt a five year Implementation Plan that shall contain the estimated expenditures proposed to be made during the next five years.
2. The 2004 Implementation Plan, as amended in June 2009, provides that redevelopment funds are to be used for the following purposes:
 - Retiring the Agency's debt obligation to the City to reimburse the City's general fund for the debt service for the construction of the Library facility;
 - Preparation of the Uptown/Town Centre Specific Plan (\$1,500,000);
 - Supplementing federal funds for repairing the Carnegie Library (\$400,000);
 - Constructing sidewalks and related improvements on Riverside Avenue and 24th Street, adjacent to the Paso Robles Event Center (\$1.5 million) and in Spring and 24th Streets in front of Flamson Middle School (\$2.515 million).
3. In July 2009, the Redevelopment Agency sold \$12 million in tax increment bonds. From this sale \$1.7 million will be used to repay a portion of the Agency's debt to the General Fund for constructing the Library and about \$5.0 million will be used to undertake the activities listed above under the "Needs" section of this report.

NOTE: The \$5.0 Million may be reduced by up to \$1.5 Million if the State initiative to take Redevelopment funds is not overturned by the Courts.

4. In order to use redevelopment funds for these activities, the Implementation Plan must be amended.
5. A public hearing has been scheduled for the Agency's meeting of September 1, 2009 for the amendment of the Implementation Plan. Public notice was given as required by the Community Redevelopment Law. A copy of the newspaper/posted notice is attached.

Analysis &
Conclusion:

Redevelopment Plan (1987)

Attached, as Exhibit B to the proposed resolution amending the plan, are excerpts from the Redevelopment Plan that list those objectives of the plan (Section 400.10) and techniques that may be used to achieve those objectives (Section 600.00 et seq.) which would be applicable to the activities listed above.

The assistance to the County Office of Education would address Objectives 1, 3, 7, 10 and 12.

The remediation and repair of damage to the City Hall parking lot caused by the 2003 San Simeon earthquake would address Objectives 1, 3, 4, and 7.

The acquisition of property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park would address Objectives 1, 3, 4, 5, 6, 7, 10, 12, and 13.

Redevelopment Implementation Plan (2004)

The 5 year objectives in Chapter IV include the following objectives to implement the 15 Redevelopment Plan Objectives and General Plan Goals for the term of the Implementation Plan:

1. Improve those transportation systems necessary to enhance the City's position as the North County commercial center, to facilitate the City's efforts to become a tourist destination and to further the City's efforts to attract and retain businesses, realizing that the hub of these systems is located within the Redevelopment Project Area.
2. Revitalize the downtown through a comprehensive effort to include, but not be limited to: improving and developing public facilities...
3. Provide affordable and safe housing for low and moderate income households.
4. Provide for Project Area-wide beautification and maintenance programs.
5. Improve public infrastructure and utilities throughout the Project Area.

The proposed activities would address the above Objectives of the Redevelopment Implementation Plan.

Exhibit A of the attached Resolution amending the Redevelopment Implementation Plan is a revised text of Chapter 4, which adds the proposed activities. Additions to the text are noted in **bold, underlined text**; deletions are noted in ~~double strikethrough text~~. A paragraph referring to an expected State take away in 2008 is to be deleted as that event did not occur.

Policy

Reference: Community Redevelopment Law (Sections 33000 et seq. of the Health and Safety Code); 1987 Redevelopment Plan; 2004 Redevelopment Implementation Plan

Fiscal

Impacts: The Implementation Plan itself is a plan for projects and programs utilizing redevelopment agency funds. There would be no expenses to the general fund.

Options:

After accepting any public testimony on the proposed amendment to the Implementation Plan, that the Redevelopment Agency take one of the following options:

a. Adopt attached Resolution RA09-XXX approving an amendment to the 2004 Redevelopment Implementation Plan to provide that the following activities may be pursued within the period of the plan:

(1) Provide assistance to the San Luis Obispo County Office of Education for the development of a center for childhood school readiness program and parent education, in conjunction with the First 5 Commission of San Luis Obispo County. The initial contribution of \$240,000 will come from funds held by the Agency in trust for COE facilities, and may include other future Agency contributions.

(2) Supplement funds from the Federal Emergency Management Agency to remediate and repair the damage to the City Hall parking lot caused by the 2003 San Simeon earthquake.

(3) Acquire property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park.

b. Amend, modify, or reject the above options.

A RESOLUTION OF THE PASO ROBLES REDEVELOPMENT AGENCY
AMENDING THE REDEVELOPMENT IMPLEMENTATION PLAN
TO ADD PROJECTS FOR WHICH REDEVELOPMENT FUNDS MAY BE USED

WHEREAS, on December 21, 2004, the Paso Robles Redevelopment Agency (“Agency”), via resolution RA 04-03, adopted an Implementation Plan pursuant to Section 33490 of the State Health and Safety Code; and

WHEREAS, the 2004 Implementation Plan, as amended on June 16, 2009, via Resolution RA 09-003 provides that redevelopment funds are to be used for the following purposes:

- Retiring the Agency’s debt obligation to the City to reimburse the City’s general fund for the debt service for the construction of the City Hall/Library facility;
- Preparation of the Uptown/Town Centre Specific Plan (\$1,500,000);
- Supplementing federal funds for repairing the Carnegie Library (\$400,000); and
- Constructing sidewalk and street improvements adjacent to Flamson Middle School

WHEREAS, the Agency and City wish to undertake the following additional activities in order to eliminate blight and address the Objectives of the Redevelopment Plan (1987) and Redevelopment Implementation Plan (2004):

- a. To provide assistance to the San Luis Obispo County Office of Education for the development of a center for childhood school readiness program and parent education, in conjunction with the First 5 Commission of San Luis Obispo County. The initial contribution of \$240,000 will come from funds held by the Agency in trust for COE facilities, and may include other future Agency contributions;
- b. To supplement funds from the Federal Emergency Management Agency to remediate and repair the damage to the City Hall parking lot caused by the 2003 San Simeon earthquake; the estimated supplementary amount is \$300,000;
- c. To acquire property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park; the estimated cost of the Park restrooms is \$1.5 million; the estimated costs of other facilities is not known; and

WHEREAS, to enable the above-listed activities to be undertaken during the period of the 2004 Redevelopment Implementation Plan, Chapter IV Goals, Objectives, Programs and Expenditures for the Next Five Years is proposed to be amended as shown in Exhibit A of this Resolution; and

WHEREAS, the Agency finds that the proposed activities address those objectives of the 1987 Redevelopment Plan, as recited in Exhibit B of this resolution, in the following manner:

- a. The assistance to the County Office of Education would address Objectives 1, 3, 7, 10 and 12;
- b. The remediation and repair of damage to the City Hall parking lot caused by the 2003 San Simeon earthquake would address Objectives 1, 3, 4, and 7;
- c. The acquisition of property for and/or develop and construct certain public facilities in the

Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park would address Objectives 1, 3, 4, 5, 6, 7, 10, 12, and 13; and

WHEREAS, a public hearing was set for September 1, 2009, and notice was given in accordance with Section 33490 of the California Health and Safety Code; and

WHEREAS, at its meeting of September 1, 2009, the Redevelopment Agency conducted a public hearing on the proposed amendment to the Implementation Plan and took the following actions:

- a. Considered the facts and analysis, as presented in the draft staff report for the proposed amendment;
- b. Considered public testimony on the proposed amendment to the Implementation Plan;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1: To amend the Implementation Plan to provide that during the period of the plan (December 2004 – December 2009), redevelopment funds may be used for the following activities:

- a. To provide assistance to the San Luis Obispo County Office of Education for the development of a center for childhood school readiness program and parent education, in conjunction with the First 5 Commission of San Luis Obispo County. The initial contribution of \$240,000 will come from funds held by the Agency in trust for COE facilities, and may include other future contributions.
- b. To supplement funds from the Federal Emergency Management Agency to remediate and repair the damage to the City Hall parking lot caused by the 2003 San Simeon earthquake.
- c. To acquire property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park.

The text of the Implementation Plan shall be amended as shown on Exhibit A of this resolution.

Exhibit A

IV GOALS, OBJECTIVES, PROGRAMS AND EXPENDITURES FOR THE NEXT FIVE YEARS

1. Redevelopment Plan Goal and Objectives

Section 400.00 of the Redevelopment Plan includes a statement that the goal of redevelopment is “to eliminate and mitigate the aspects of existing and anticipated visual, economic, physical, social and environmental blight within the Project Area.” Section 400.10 lists 15 objectives which support this goal. These sections are contained within Appendix B of this Implementation Plan.

2. General Plan Goals

The General Plan, adopted in 2003, contains the following Goals:

GOAL 1: In order to enhance Paso Robles’ unique small town character and high quality of life, the City Council supports the development and maintenance of a balanced community where the great majority of the population can live, work and shop.

GOAL 2: Strengthen the City’s economic base through business retention and recruitment, including provisions for “head-of-household” jobs and increased retail sales, transient occupancy taxes, and property tax revenues.

GOAL 3: Establish Paso Robles as the North County commercial retail center, based on providing neighborhood and service commercial development in proportion to population growth, downtown commercial revitalization, and regional commercial development.

GOAL 4: Strive to ensure that City services and facilities are maintained at current levels and/or in accordance with adopted standards.

3. Implementation Plan Objectives (5 Years)

The following objectives are formulated to implement the 15 Redevelopment Plan Objectives and General Plan Goals for the next 5 years:

1. Improve those transportation systems necessary to enhance the City's position as the North County commercial center, to facilitate the City's efforts to become a tourist destination and to further the City's efforts to attract and retain businesses, realizing that the hub of these systems is located within the Redevelopment Project Area.

2. Revitalize the downtown through a comprehensive effort to include, but not be limited to: improving and developing public facilities; attraction of businesses such as theaters, restaurants, hotel and conference center; and commercial rehabilitation.

3. Provide affordable and safe housing for low and moderate income households.

4. Provide for Project Area-wide beautification and maintenance programs.

5. Improve public infrastructure and utilities throughout the Project Area.

4. Programs

Transportation Systems Improvement: Programs for which use of Redevelopment Funds has been targeted include improvements to South River Road and connecting bikeways (related to the development of Woodland Plaza II), for construction of sidewalks and related improvements (curbs, gutters, retaining walls, street lights, and street trees) along the 24th Street and Riverside Avenue frontages of the Paso Robles Event Center, and for construction of sidewalks and related improvements on the Spring and 24th Street frontages of Flamson Middle School.

Possible future programs to be supported with Redevelopment Funds may include: support for 13th Street/Creston Road Corridor improvements, support for the Spring Street Reconstruction program, support for transit facilities (e.g. bus shelters); and other programs.

Downtown Revitalization: Possible future programs to be supported with Redevelopment Funds may include: repair and rehabilitation of the historic Carnegie Library Building (e.g., repair of damage caused by the 2003 San Simeon Earthquake, seismic retrofit, disabled access and other activities to renovate and convert the building to other uses); efforts to attract uses such as theaters, performing arts venues, restaurants, hotel and conference facilities (including parcel assemblage, if necessary); efforts to provide more parking (including, possibly, one or more parking lots and/or structures); further improvements to City Park; support for commercial rehabilitation (which has been approved for funding via federal Community Development Block Grant monies); preparation of specific plans for development and revitalization of the Uptown and Town Center Areas; **design and build new restrooms for City Park (bounded by Spring, Pine, 11th, and 12th Streets) to replace and expand the existing restrooms, which are deteriorating;** and other programs.

Affordable and Safe Housing: Future housing programs are discussed in detail in Chapter V. Briefly, such programs may include: first-time home buyer assistance for very low, low, and moderate income households; assistance to development of new rental housing; assistance to efforts to conserve subsidized apartments at risk of conversion to market rate; loan programs for residential rehabilitation; and other programs.

Beautification and Maintenance: Possible future programs to be supported with Redevelopment Funds may include support for Phases 2 and 3 of the Spring Street Reconstruction (landscaping, street furniture and lighting); street tree planting; freeway frontage landscaping; and other programs.

Public Facilities, Infrastructure and Utilities: Possible future programs to be supported with Redevelopment Funds may include: downtown parking improvements, support for storm drain improvements; water and sewer system upgrades; undergrounding of overhead electrical and/or telephone wires; **supplement funds from the Federal Emergency Management Agency to remediate the impacts associated with the hot spring that emerged at the northeast corner of Spring and 10th Streets as a consequence of the 2003 San Simeon Earthquake; development of a center for childhood school readiness programs and parent education at the northeast corner of Oak and 36th Streets to serve the education needs of the Project Area and surrounding community; acquisition of property for public facilities, infrastructure and utilities;** and other programs.

5. Expenditures of Redevelopment Funds in the Next 5 Years

In addition to the two formal tax allocation bond issues, in 1996 for \$3,630,000 and in 2000 for \$4,090,000, the only “debt” obligation has been a commitment for the Agency to reimburse the City’s general fund for the debt service for the construction of the City Hall/Library Building. Through June 30, 2007, all net available resources, the amounts shown in the “annual balance” column below, had been earmarked for this purpose.

The amounts contained in the “net tax increment revenue” column are net after all fiscal agreement payments due to other taxing agencies have been paid.

~~Not included in this table are the State takeaways to balance their budget deficit. In fiscal year 2005, the amount is \$111,000. The fiscal year 2008-09 payment is \$244,603.~~

The chart below does not include revenues and expenditures for the Low and Moderate Income Housing (LMIH) Fund. Those will be shown and discussed in Chapter V.

NOTE: Maintenance and Operations includes fiscal agreement payments to Paso Robles Public Schools, SLO County Schools, Cuesta College.

Via a Reimbursement Agreement between the Redevelopment Agency and City Council dated November 1, 1993, the Redevelopment Agency was obligated to reimburse the City for the debt service payments arising out of the construction financing for the City Hall/Library located at 1000 Spring Street. More specifically, this agreement required that all non-LMIH funds not appropriated for operational needs and debt service requirements (net of fiscal agreements) be used to repay the reimbursement obligation. The Reimbursement Agreement was replaced by the 2004 Reimbursement Agreement after the 1993 bonds were defeased and prepaid by the 2004 Refunding Certificates of Participation.

Those funds available to the Agency after payment of the Agency's existing debt service will be used to fund its programs listed above. Although the timing and priority for expenditure of those funds will be dependent on the amount of funding available from time to time, the Agency anticipates allocating approximately ~~\$5.915~~ **\$5 million for the following projects during the Implementation Plan period:**

- a. To provide gap funding for repair of the earthquake damage to the historic Carnegie Library Building **(\$400,000 estimated cost)**;
- b. ~~for~~ Preparation of the Uptown and Town Centre specific plans **(\$1.5 million estimated cost)**;

and

- ~~c. To construct for the costs of construction of sidewalks and related improvements in 24th Street and Riverside Avenue, adjacent to the Paso Robles Event Center, and in Spring and 24th Streets adjacent to Flamson Middle School (**\$2.5 million estimated cost**); during the Implementation Plan period.~~
- d. To assist the San Luis Obispo County Office of Education and the First 5 Commission of San Luis Obispo County develop a center for childhood school readiness programs and parent education at the northeast corner of Oak and 36th Streets to serve the education needs of the Project Area and surrounding community. Towards this end, the Agency will allocate approximately \$240,000 Redevelopment Funds that are being held in trust for the County Office of Education and will allocate Redevelopment Funds adequate to finance \$1 million in debt necessary to develop the center. The amount of funds to be allocated for the latter will be budgeted at \$80,300 per year for a period of 20 years.**
- e. To supplement funds from the Federal Emergency Management Agency to remediate the impacts associated with the hot spring that emerged at the northeast corner of Spring and 10th Streets as a consequence of the 2003 San Simeon Earthquake (\$300,000 estimated cost);**
- f. To design and build new restrooms for City Park (bounded by Spring, Pine, 11th, and 12th Streets) to replace and expand the existing restrooms, which are deteriorating (\$1.5 million estimated cost);**
- g. To acquire property in the Redevelopment Project Area for public facilities needed to eliminate blight and implement the Redevelopment Plan (costs unknown and would vary with each facility).**

6. Elimination of Blight

A matrix showing how the objectives and programs will eliminate blight, using the AB 1290 definition of blight, is provided on the next page.

SECTION 400.00 Redevelopment Objectives

Section 400.10 General Project Objectives

The Agency proposes to use the process of redevelopment to eliminate and mitigate the aspects of existing and anticipated visual, economic, physical, social, and environmental blight within the Project Area.

Within the broad goals, and as an indicator in the evaluation and determination of project priorities, the following specific redevelopment objectives are established by the Agency:

1. The elimination of existing blighted conditions, be they properties or structures, and the prevention of recurring blight in and about the Project Area...
3. The development of public services and facilities including, but not limited to, police and fire, city administration, cultural recreational, maintenance, and operational services and facilities as are necessary and required for the redevelopment of the Project Area.
4. The elimination of environmental deficiencies including inadequate street and freeway improvements, inadequate utility systems, and inadequate public services; and mitigation of the potential social, physical, and environmental characteristics of blight.
5. The development of a more efficient and effective circulation corridor system free from hazardous vehicular, pedestrian, and bicycle interfaces and designed to their ultimate circulation flow.
6. The implementation of techniques to mitigate blight characteristics resulting from exposure to freeway, railroad and public right-of-way corridor activity and affecting adjacent properties within the Project Area.
7. Beautification activities to eliminate all forms of blight including, but not limited to, visual blight, in order to encourage community identity...
10. The creation of a more cohesive and unified community by strengthening the physical, social, and economic ties between residential, commercial, industrial, and recreational land uses within and adjacent to the Project Area...
12. To encourage the coordination, cooperation, and assistance of other local agencies, as may be deemed necessary, to ensure that projects undertaken by this Agency are implemented to their fullest and practical extent.
13. The achievement of a physical environment reflecting a high level of concern for architectural and urban design principles deemed important by the community and property owners...

Excerpts from the Redevelopment Plan (1987)

Section 600.00 Redevelopment Techniques to Achieve Plan Objectives

Section 600.10 General

The redevelopment of the Redevelopment Project Area will be undertaken in order to carry out the intent and purpose of the Redevelopment Law and the redevelopment objective broadly defined in the previous section of this Plan.

The Agency proposes to eliminate or alleviate the conditions of blight existing in the Project Area, to strive for economic revitalization and Project Area beautification, and to mitigate the negative social, physical, and environmental impacts resulting from existing and anticipated development or deterioration in the Project Area through the following Activities:

Section 600.11

The acquisition of real property by purchase, gift, devise, or any other lawful interest, with the specific limitations on exercising the power of eminent domain.

Section 600.12

The combining of parcels or properties, site preparation and the construction of necessary off-site improvements.

Section 600.16

Providing for open space and recreational land use.

Section 600.17

Encouraging public and private improvements so as to prevent, mitigate, or eliminate existing and/or anticipated blight conditions in the Project Area.

Section 600.20

Demolishing or removing certain existing buildings and improvements on land acquired by the Agency.

Section 600.21

The demolition, removal, rehabilitation, alteration, modernization, general improvement, or any combination thereof, of existing structures in the Project Area where such are permitted or required under the Redevelopment Plan.

Exhibit B
Excerpts from the Redevelopment Plan (1987)

Section 600.23

The preparation, by the Agency, of acquired land for building sites. In connection therewith the Agency may cause streets, bridges, railroad crossings, bikeways, and pedestrian ways to be designed, installed, constructed, or reconstructed; may cause sidewalks, curbs, and public utilities to be constructed and installed; and may cause landscaping and other on-site and off-site improvements to be completed in conformity with the Redevelopment Plan.

Section 600.91 Demolition and Clearance

The Agency is authorized, as to only property which it acquires, to demolish, clear or move buildings, structures and other improvements from any real property in the Project Area as necessary to carry out the purpose of this Plan.

Section 600.92 Public Improvements

The Agency is authorized to install and construct, or to cause to be installed and constructed, the public improvements and public utilities (within or outside the Project Area) necessary to carry out this Plan. Such public improvements include, but are not limited to, over- or underpasses, bridges, streets, curbs, gutters, sidewalks, street lights, sewers, storm drains, traffic signals, electrical distribution systems, natural gas distribution systems, water supply and distribution systems, buildings, parks, on- and off-street parking, plazas, playgrounds, landscaped areas, and other public facilities.

Section 600.93 Preparation of Building Sites

The Agency is authorized to prepare or cause to be prepared building and development sites, any real property in the Project Area owned or acquired by the Agency.

The Agency may develop a site for the authorized uses of this Plan, so as to provide streets, sidewalks, utilities, or other improvements which an owner or operator of the site would otherwise be obliged to provide with the prior consent of the City Council.

In giving consent, the City Council shall make a finding that the provision of such improvements is necessary to effectuate the purposes of the Redevelopment Plan.



- a. The initial contribution of \$240,000 will come from funds held by the Agency in trust for COE facilities, and may include other future contributions.
- b. To supplement funds from the Federal Emergency Management Agency to remediate and repair the damage to the City Hall parking lot caused by the 2003 San Simeon earthquake.
- c. To acquire property for and/or develop and construct certain public facilities in the Redevelopment Project Area, including, but not limited to, the replacement of public restrooms in City Park.

The proposed use of redevelopment funds will be based on a proposed finding that the projects will provide benefit to the Redevelopment Project, advancing objectives set forth in both the 1987 Redevelopment Plan and the 2004 Redevelopment Implementation Plan.

This hearing will take place in the Library Conference Center at Library/City Hall, 1000 Spring Street, Paso Robles, California, at 7:30 PM on Tuesday, September 1, 2009, at which time all interested parties may appear and be heard.
