SUBJECT:	Water Rates – Low Income Relief Legislation

TO:	City Council

- **NEED:** For the City Council to consider authorizing the Mayor to sign letters urging State legislation that would allow local rate payers to provide low income price supports for water and sewer service.
- FACTS: 1. Paso Robles water rates must be adjusted to cover the costs of providing water.
  - 2. California's Proposition 218 requires that property-related service rates be set at levels that do not exceed the proportional cost of the service attributable to a parcel.
  - 3. Paso Robles property owners and rate payers have expressed an interest in providing price breaks for low income households.
  - 4. Provision of price supports for low income households would require other's rates to increase to offset the discounts.
  - 5. The Proposition 218 provision cited above prohibits such a rate plan.
  - 6. The City will establish a voluntary donation fund to offer financial aid to low income households, but more may be needed.
  - 7. The City Council may urge the State Legislature to provide local property owners and rate payers the opportunity to establish rates that include low income price supports.

## ANALYSIS &

**CONCLUSION:** It is not clear that California voters intended to eliminate options to provide for low income households when they approved Proposition 218. Locally, many property owners and rate payers have expressed a desire to extend financial aid to low income households by providing discounted utility rates. Unfortunately, they cannot.

It is reasonable and appropriate to request of the State Legislature legislation that frees property owners and rate payers to extend such consideration if they wish. Letters urging same are attached for Council consideration.
