8. Water Rates – Low Income Relief Legislation

For the City Council to consider authorizing letters urging State legislation that would allow local rate payers to provide low income price supports for water and sewer service.

Councilmember Hamon, seconded by Councilmember Strong, moved to adopt Resolution No. 10-013 selecting a uniform water rate structure; authorize initiation of the Proposition 218 procedures, and; instruct staff to send out public notices regarding the proposed water rate structure.
