NEEDS: For City Council to consider a resolution confirming the provision of Workers' Compensation Insurance to certain Volunteers.

FACTS: 1. The City engages the services of numerous volunteers to implement certain City

2. Volunteers who perform scheduled work to deliver certain governmental services

- 3. The City's Workers' Compensation Insurance coverage has historically been extended to City volunteers.
- 4. A Risk Management audit identified that a formal resolution is appropriate to endorse the volunteer workers' compensation plan.

ANALYSIS & CONCLUSION:

Volunteers are a valuable resource in delivering services to the public. They often function in a capacity similar to paid employees who are covered by workers' compensation benefits. It is logical and beneficial to continue to extend the workers' compensation benefit to certain volunteers.

FISCAL

IMPACT: The City's past practice has been to extend workers' compensation coverage to its

volunteers. Formal adoption of a resolution endorsing this practice will not,

therefore, increase costs.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES PROVIDING WORKERS' COMPENSATION COVERAGE FOR CERTAIN CITY VOLUNTEERS PURSUANT TO THE PROVISIONS OF SECTION 3363.5 OF THE LABOR CODE.

WHEREAS, the City of El Paso de Robles finds its best interest will be served by utilizing volunteers in the provision of certain government services; and

WHEREAS, said volunteers are eligible for workers' compensation coverage while on duty;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of El Paso de Robles does hereby:

- 1. Find and determine that the public interest in best served by providing workers' compensation coverage for City volunteer workers as specified by the City Manager; and
- 2. Provide eligibility for said volunteers for workers' compensation benefits which will be applicable during the time the person actually performs volunteer services, provided, however, that the rights of volunteers shall be limited as set forth in the Labor Code.
