SUBJECT: Department of Justice Originating Agency Identifier – Modified Resolution

DATE: May 18, 2010

NEEDS:

For the City Council to rescind a previously approved resolution and adopt a new resolution with amended language to authorize the Human Resources Manager to obtain a Department of Justice Originating Agency Identifier (ORI) number.

FACTS:

- 1. On May 4, 2010, the City Council adopted Resolution 10-055 which authorized the Human Resources Manager to obtain an ORI number from the State Department of Justice (DOJ).
- 2. After filing the ORI application and resolution with the State, the DOJ notified the City that there were specific verbiage modifications necessary to the resolution in order for them to continue processing the application.
- 3. To implement the DOJ's directive it will be necessary to rescind Resolution 10-055 through resolution action, and then adopt a new/separate resolution with the specific language amendment.
- 4. The proposed amendment is to delete text as shown in strike-through font as follows:
 - "NOW THEREFORE, BE IT RESOLVED, that the City of Paso Robles is hereby authorized to access state and federal level summary criminal history information for employment in Emergency Services (including volunteer and contract employees) licensing, or certification purposes and may not disseminate the information to a private entity; and
- 5. A Department of Justice ORI number is required to receive criminal history and subsequent arrest information.
- 6. Emergency Medical Technician (EMT) certified employees undergo a state criminal background check as part of their initial hiring process.
- 7. New state regulations will require EMT certified employees to complete both a state and federal criminal background check.
- 8. Human Resources holds an ORI number that limits access to state criminal history information. A new application and ORI number will be required to receive both state and federal criminal history information.

ANALYSIS & CONCLUSION:

Emergency Services' employees undergo a rigorous background investigation prior to hire. Background investigation includes "live scan" fingerprint process to determine criminal history. This check has been limited to criminal history collected at the state level.

New state regulations will require all California EMT's to undergo a criminal background check that includes both state and federal sources. Obtaining a designated ORI number will allow criminal background results and subsequent arrest notifications at the state and federal levels to be provided directly to Human Resources.

The proposed resolution amendment is required by the State DOJ to allow the continued processing of an ORI number as described within this report.

WHEREAS, after filing the ORI application and resolution with the State, the DOJ notified the City that there were specific verbiage modifications necessary to the resolution in order for them to continue processing the application; and

WHEREAS, to implement the DOJ's directive it will be necessary to rescind Resolution 10-055 and then adopt a new and separate resolution with the required specific language amendment.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of El Paso de Robles hereby rescinds Resolution 10-055 (Attached as Exhibit A) which authorized the Human Resources Manager to process a request through the State Department of Justice for a modified Originating Agency Identifier to access state and federal level summary criminal history information for employment purposes.
