Facts:

1. Randall Moos served a two year term on the Parks and Recreation Advisory Committee, July 2008 – June 2009. He did not apply for reappointment when his term was up.
2. There were two vacancies on Parks and Recreation Advisory Committee for the two year terms beginning July, 2010. One person applied for a position and was appointed. The second seat is currently vacant.
3. When Mr. Moos was notified that a vacancy exists, he reconsidered his decision and applied for reappointment.

Conclusion: There is currently one vacancy on the Parks and Recreation Advisory Committee. An outgoing member, Randall Moos, has applied for the position.

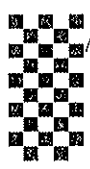
