• REC Foundation has just approved spending \$48,000 to purchase shade structures at Barney Schwartz Park to put over the soccer areas. In last two years, REC Foundation has donated over \$350,000 to augment the City's parks, library, and recreation programs.

- Mayor Picanco discussed the Fourth of July Fireworks will not happen this year due to a lack of funds. We are accepting donations now and hopefully we will have enough collected to have fireworks in 2011. We will have a Labor Day Car show.
- We are into our second year of using City reserve funds to get through the recession. Some cities are close to bankruptcy. It is a compliment to the City and their planning has kept our head above water and fiscally responsible. The City is still working on water rate and waste water treatment plant.
- Councilman Steinbeck gave an update about the June 15, 2010 Council agenda.
