SUBJECT: Theatre Drive Realignment – Contract Award

DATE: September 7, 2010

FACTS:

**NEEDS:** For City Council to consider awarding a contract for a realignment project at Theatre Drive.

1. In April 2005, a Project Study Report (PSR) was approved by Caltrans that identified alternatives to improve safety and reduce congestion in and around the US Route 101/46 West interchange. Recommendations include:

- a) Realign Theatre Drive to the west from its current connection to Highway 46.
- b) Realign Vine Street to connect with Highway 46W west of its current location and in alignment with the realigned Theatre Drive.
- c) Construct west roundabout to accommodate Highway 101/46 traffic movement.
- d) Construct east roundabout to accommodate Highway 101/46 traffic movement.
- 2. In March 2009, SLOCOG programmed \$2,860,000 of ARRA grant funds for a City project to realign Theatre Drive consistent with the 2005 PSR.
- 3. In January 2010, the Federal Highway Administration (FHWA) authorized the fund appropriation allowing the City to secure bids.
- 4. The project was advertised for bids on June 28, 2010.
- 5. In early July 2010, Caltrans notified the City that bids received for many construction projects were much lower than anticipated and should the bids for the Theatre Drive Project be less than the \$2,860,000 ARRA grant, the City may have to return the remaining balance.
- 6. As a result staff issued project bid additives that had previously been removed from the project scope to achieve compliance with early construction estimates.
- 7. To that end, the City issued a bid addendum to include the following bid additives:
  - A) Gahan Reconstruction
    Pavement is deteriorated and would further deteriorate during construction.
    Staff included a bid additive to reconstruct this road.
  - B) Bike Lane Colorization

Although bike lanes are part of the original budget, colorization of the bike lanes similar to the adopted treatment along South Vine, was not included in the budget. In order to maintain the standard, a bid additive to colorize the bike lanes was added.

C) Expand Ornamental Landscape

The project had reduced areas for ornamental landscaping. The bid additive return the landscape to original design levels along the west perimeter of the realigned Theatre Drive.

8. At the bid opening on August 19, 2010 the City received 9 bids ranging from \$1,811,192 to \$2,363,694 including the bid alternatives as follows:

WHEREAS, in April 2010 the City Council accepted an ARRA grant in the amount of \$2,860,000.

## THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1</u>. The City Council of the City of El Paso de Robles does hereby award a contract for Theatre Drive Realignment Phase 1 to R. Burke Corporationin the amount of \$1,811,192, which includes the Base Bid and Additive Bid Items A, B and C, and authorizes the City Manager to execute the contract
