SUBJECT: TPRA and PCC – Extension of Term Assignments

DATE: November 16, 2010

NEEDS: For the City Council to consider extending the terms of expiring advisory committee

appointments for both the Travel Paso Robles Alliance (TPRA) and the Promotions

Coordinating Committee (PCC).

FACTS: 1. <u>The Promotions Coordinating Committee (PCC)</u>:

• Was established in August of 2007 as part of the restructuring of City wide tourism and promotion efforts.

- Consists of seven members, including the CEO/Executive Directors
  of the Wine County Alliance, Events Center, Main Street and
  Chamber of Commerce, as well as two hoteliers and one business
  person with significant marketing expertise.
- The non-permanent members serve staggered 2-year terms.
- Matt Masia is one of the non-permanent hotelier representatives. His term will expire October 31, 2010.
- 2. The Travel Paso Robles Alliance (TPRA):
  - Was established in 2009 in conjunction with the formation of the Tourism and Lodging Promotions Business Improvement District (BID).
  - The BID established a 2% supplementary transient occupancy tax as a funding source for promotional efforts that benefit the Paso Robles lodging industry.
  - The TPRA consists of seven members who advise City Council on the marketing/spending priorities for funds generated by the BID.
  - To be eligible for membership on the TPRA, a person must be a hotelier, and two of the seven members are to be the hotelier members of the PCC.
  - Members are appointed for 3-year staggered terms.
  - Three TPRA member terms will expire October 31, 2010 as follows:

Matt Masia – PCC Hotelier Kimberly Foo – Hotelier Victor Popp – Hotelier

- 3. The TPRA's promotions contractor, Mental Marketing, reached out to hoteliers to determine who might be interested in continuing their service and whether there were new committee member interests from other hoteliers. All three existing TPRA members indicated an interest in a renewed term, and Matt Masia indicated interest in a renewed PCC term as well.
- 4. At their meeting of October 26, 2010, the TPRA voted 4-0 (unanimous for the guorum in attendance) to recommend to the City Council that they reappoint the current slate of TPRA members, with Matt Masia as the crossover hotelier on the PCC.
- At the same October 26<sup>th</sup> meeting, the TPRA indicated their intention to 5. reach out to hotel members and invite/encourage their attendance at regular TPRA meetings as a means of cultivating future TPRA member candidates.

## ANALYSIS AND

CONCLUSION: The TPRA is a relatively new advisory committee, where since 2009 there has been a fast paced learning curve for each committee member. The four hoteliers whose terms are not yet up, expressed the desire to see the existing three "incumbent" TPRA members continue to serve. The continuity of membership in this formative period of the TPRA's efforts was identified as healthy and stabilizing. The commitment to orient additional hoteliers to the committee's work over the coming months will grow the pool of experienced member candidates for the future.

> The willingness of Matt Masia to continue to serve on both the PCC and the TPRA provides the continued crossover of hotelier experience that the TPRA bylaws envision.
