

RESOLUTION NO. 10-xxx

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES,
RECITING THE FACTS OF THE CONSOLIDATED GENERAL ELECTION HELD ON
NOVEMBER 2, 2010, DECLARING THE RESULT AND SUCH OTHER
MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Election was held and conducted in the City of El Paso de Robles, California, on Tuesday, November 2, 2010 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY OF EL PASO DE ROBLES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:

SECTION 1. That the names of persons voted for at the election for Mayor are as follows: Duane Picanco, Gary Nemeth, and Michael D. Gibson;

That the names of persons voted for at the election for Member of the City Council are as follows: John R. Hamon, JR., Greg Rachunok, and Ed Steinbeck;

That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates are listed in Exhibit "A" attached.

SECTION 2. The City Council does declare and determine that Duane Picanco was elected as Mayor for the full term of two (2) years; and John Hamon and Ed Steinbeck were elected as Members of the City Council for the full term of four (4) years.

SECTION 3. The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; and (4) the total number of votes given to each person.

SECTION 4. That the City Clerk shall make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California, subscribed and filed in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 5. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the file of original resolutions.
