He also reported the City Park restrooms will be renovated. The January 18, 2011 City Council meeting will be very important including work on the Uptown/Towne Centre Plan. At their December 21, 2010 meeting, the Council realigned their Council appointments as follows: John Hamon is now the Mayor Pro Tem and Councilman Strong has assumed new responsibilities. All other City advisory committee liaisons remain the same.
