NEEDS: For City Council to consider awarding a contract to install bus shelters and benches.

FACTS: 1. The City received an ARRA (Transit) Grant to install shelters, benches and trash receptacles at two bus stop locations. The grant amount available is \$17,400.

2. Bid documents were prepared and advertised.

3. At the bid opening on February 17, 2011, nine bids were received as follows:
