11. Zoning Regulations for Nonconforming Uses

For the City Council to consider options for revising zoning regulations for nonconforming uses to provide economic relief to property owners.

Councilmember Strong, seconded by Councilmember Steinbeck, moved to incorporate the proposed amendments into the Uptown/Town Centre Specific Plan (Chapter 5) and that a code amendment to incorporate them into the Zoning Code be initiated. The motion included revising the text of subsection "f" to add "but not limited to" following "include" in the third sentence.

12. 21st Street Reservoir Maintenance

Councilman Gilman, seconded by Councilman Strong moved to adopt Resolution No. 11-030 authorizing the City Manager to enter into a contract with Crosno Construction Inc. for repair work on the 21st Street Reservoir for a lump sum of \$21,700 and a contingency of \$18,600 for dehumidification and other as needed to complete the work.
