#### **DISCUSSION ITEMS**

#### 2. Park Safety Presentation

- a) Paso Robles Police Officers Joe Ramirez, Matt Worley, and Terry Afana spoke about safety concerns in our City parks. Each officer gave a brief description of their years of service with the City of Paso Robles Police Department, family, and history in our community.
- b) The officers are asking the public's help in reporting any unlawful activity they may see in the park.
- c) Sherwood Park Charlotte Gorton, Recreation Services Manager, asked if the camera that REC Foundation purchased and installed on the new dragon playground apparatus has helped the Police Department deter vandalism and in the park.
  - 1. Officer Worley advised "Yes, the camera has helped."
  - 2. The officers advised lack of lighting in Sherwood Park is a major problem.

- d) Pioneer Park Officers said there is more of a homeless problem in this park.
- e) The Committee asked what the Police would like from the community:
  - a. People to get more involved, don't look the other way, and to call the police.
  - b. Put the Police Department's phone number in your cell phone.
  - c. Lock your car, bicycle, and home. Hide your phone and other valuables if you leave them in the car.
  - d. Don't leave your purse unattended in a cart in the store. Take away the temptation for people to steal.
  - e. Be aware of your surroundings. If you hear the neighborhood dog barking, look outside to see what is causing the dog to bark. It could be your neighbor needs help a robbery, fire, etc.

#### 3. Recreation User Groups

- a) The resignation of the LRS Sports Coordinator has prompted some changes in job assignments.
- b) Our Department is considering public proposals to take over some of the recreation programs. The committee is advised to wait until after final decisions are made before making presentations to parks and recreation user groups.
- c) Councilman Gilman encouraged members to be pro-active and maintain communication with the user groups. He also encouraged members to be the liaison between the public and Council.

#### 4. Guest Speaker - Community Action Partnership Senior Health Screenings

- o Heather Murphy, RN and Senior Health Screening Supervisor explained this is a non-profit, mobile, health care group that offers free public clinics at 12 sites within San Luis Obispo County. The free program is intended for patrons 50 years and up; if a lipid panel is called for there will be a charge of \$20.
- o Health screenings are held at the Paso Robles Senior Center the 4<sup>th</sup> Wednesday of every month from 9 a.m. to noon and service approximately 12 to 15 people within a three-hour time frame.
- o Funding is provided by grants and donations; the group's major yearly fundraiser is at the Chapman House in Nipomo.

#### 5. **2011 Commissioners Workshop at Hearst Castle February 26**

o Charlotte Gorton, Recreation Services Manager, gave a run-down of the February 26 Commissioner's Workshop at Hearst Castle and took registration for three members.
