CHESTNUT STREET (SOTO)

DATE: JUNE 7, 2011

Needs: For the City Council to consider a request by Tina Soto, to remove one oak

tree on her property located at 1120 Chestnut Street.

Facts: 1. The subject oak tree is a 23-inch Coast Live Oak (Quercus Agrifolia).

2. As described in the letter from Chip Tamagni of A&T Arborists (Attachment 1), the tree has an excessive lean, and is targeting the home. As a result of the leaning tree, Ms. Soto is requesting to remove the tree.

- 3. The tree is in good health, however, the growth characteristics of the tree have caused it to lean to a point that could damage the home in the future if and when the tree was to fail.
- 4. Section 10.01.050.C of the Oak Tree Ordinance requires that the City Council make the determination of whether a healthy tree should be removed or not, after consideration of the factors listed in Section 10.01.050.D.

Analysis And Conclusion:

According to Section 10.01.050.D, there are several factors that the City Council needs to review when considering the removal of a "healthy" oak tree. These factors along with Staff's analysis of each factor are listed below:

- D. If a request is being made to remove one or more healthy oak trees for which a permit to remove is required, the director shall prepare a report to the City Council, outlining the proposal and his recommendation, considering the following factors in preparation of his recommendation.
 - 1. The condition of the oak tree with respect to its general health, status as a public nuisance, danger of falling, proximity to existing or proposed structures, interference with utility services, and its status as host for a plant, pest or disease endangering other species of trees or plants with infection or infestation;

 Chip Tamagni, from A&T Arborists submitted the necessary.

Chip Tamagni from A&T Arborists submitted the necessary information requesting to remove the tree on May 9, 2011. The report

(Attachment 1) indicates that the tree has an excessive lean and eventually could fall on the house if not removed.

2. The necessity of the requested action to allow construction of improvements or otherwise allow reasonable use of the property for the purpose for which it has been zoned. In this context, it shall be the burden of the person seeking the permit to demonstrate to the satisfaction of the director that there are no reasonable alternatives to the proposed design and use of the property. Every reasonable effort shall he made to avoid impacting oak trees, including but not limited to use of custom building design and incurring extraordinary costs to save oak trees;

Allowing the removal of the tree will eliminate the risk of the tree falling and damaging the house. Because of the severe lean of the tree, it does not appear that there are other alternatives to prevent the tree from damaging the house in the future if it were to fall.

3. The topography of land, and the potential effect of the requested tree removal on soil retention, water retention, and diversion or increased flow of surface waters. The director shall consider how either the preservation or removal of the oak tree(s) would relate to grading and drainage. Except as specifically authorized by the planning commission and city council, ravines, stream beds and other natural water-courses that provide a habitat for oak trees shall not be disturbed;

There would not be any negative effects on soil retention, water retention or surface water flows for the neighborhood, if this tree were to be removed.

4. The number, species, size and location of existing trees in the area and the effect of the requested action on shade areas, air pollution, historic values, scenic beauty and the general welfare of the city as a whole;

The applicant is willing to plant the necessary replacement trees as required by the Oak Tree Ordinance.

5. Good forestry practices such as, but not limited to, the number of healthy trees the subject parcel of land will support.

There are other oak trees on the site that will not be impacted by the removal of this tree.

Planning Staff along with Building Staff have been to the site to observe the tree, and would agree that the tree is a good candidate for removal.

Options:

Adopt Resolution No. 11-xx approving OTR 11-002, allowing the removal of the 23-inch Coast Live Oak tree, based on the tree having excessive lean that could cause damage to the existing house if it were to fail, and require one (1) 1.5-inch diameter Coast Live Oak replacement tree to be plated at the direction of the Arborist or payment of the necessary funds to the oak tree replacement fund;

B. Amend, modify or reject the above options.

Re: Oak Tree Removal at 1120 Chestnut Street


This report is in regard to a leaning, 23 inch diameter coast live oak tree (*Quercus agrifolia*) targeting the above named residence. A & T Arborists was contacted by the owner (Tina Soto) after a city building inspector (Dan Carigan) expressed concern regarding the tree's excessive lean. He recommended she consult an arborist to evaluate the hazard. We subsequently inspected the tree and looked into the possibility of pruning the tree or asking for a removal. The lean of the trunk exceeds 45 degrees and directly targets the home. The lean is a result of years of suppression from neighboring trees. We feel that any mitigation pruning would not achieve the desired safety level. We have included a photograph of the tree. We are hereby requesting permission to remove the tree before it fails into the home.





RESOLUTION NO. 11-xxx

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES AUTHORIZING THE REMOVAL OF ONE OAK TREE AT 1120 CHESTNUT STREET (TINA SOTO)

WHEREAS, Tina Soto has submitted a request to remove a 23-inch Coast Live Oak Tree on her property located at 1120 Chestnut Street; and

WHEREAS, the tree has a severe lean and if it fails could damage the existing house; and

WHEREAS, the Director could not make the determination that the tree is "clearly dead or diseased beyond correction," and therefore, Section 10.01.050.C of the Oak Tree Ordinance would consider the tree "healthy" and require that the City Council make the determination of whether the tree should be removed or not, after consideration of the factors listed in Section 10.01.050.D; and

WHEREAS, Chip Tamagni of A & T Arborists submitted an Arborist Report indicating that the tree is in good condition, but recommends that the tree be removed to prevent future damage to the house; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of El Paso de Robles does hereby:

- 1. Authorize the removal of one (1) 23-inch Coast Live Oak tree based on the tree having a severe lean that could cause damage to the house when the tree falls;
- 2. Require the planting of one (1) 1.5-inch diameter Coast Live Oak replacement tree; to be planted at the direction of the Arborist.
