SUBJECT: Award Contract to Rehabilitate/Upgrade Sewer Lines at Beverly, Bonita, 30th

and 32nd Streets

DATE: June 21, 2011

FACTS:

NEEDS: For City Council to award a contract to replace a failing wastewater line located in backyard easements at Beverly, Bonita, 30th and 32nd Streets (DPW 10-08).

1. The existing 4-inch diameter wastewater main is over 60 years old and is established in a 10-foot wide easement that lays in the rear yards of residential lots fronting on Beverly, Bonita, 30th and 32nd Streets.

2. In 2010, City staff determined that the pipeline must be upgraded in order to continue serviceability to the residents.

- 3. If awarded, the 4-inch sewer main would be replaced with an 8-inch main. However, because the existing residential units cannot relocate their private sewer laterals, the replacement line will need to be located within the exisiring rear yard easements.
- 4. Through the years, residents have encroached into the City's wastewater easement installing sheds, patios, dog houses, fences, over the City's easement. Therefore, before the City initiated the bid phase, staff met with residents in a group setting and individually at the site to discuss the need to upgrade the pipeline and the resulting disturbance.
- 5. Residents have agreed that the project is necessary and are cooperating with the City to remove conflicts in order to proceed with the project. To reduce the disturbance in rear yards the City selected a method called "pipe reaming" to upgrade the line. Pipe reaming is a trenchless method where the contractor will insert the reaming equipment into a pit, ream through the existing pipeline and pull in the new 8-inch diameter pipe.
- 6. Bid documents were prepared and the project was advertised.
- 7. At the bid opening on May 26, 2011, the City received one bid from MGE Underground in the amount of \$292,660.

## Analysis & Conclusion:

Few contractors have adequate equipment and experience to perform the pipe reaming method of construction, which is likely a reason the City received only one bid. However, the City has worked with MGE Underground on past projects and found them to be a reputable firm. In addition, the engineer's estimate for the project is \$312,000 so their bid is reasonable. Staff reviewed the low bid submitted by MGE Underground and found it to be a responsive and responsible bid.
