Needs: For the City Council to appoint a Trustee to the Paso Robles City Library Board:

Facts:

1. The term of Library Board Trustee Jerry Boxer expires as of June 30, 2011.
2. Two Library Board applicants, Pamela Alch and Nancy Major, were interviewed by four Councilmen at a public meeting on May 26, 2011 to fill one vacancy.
3. The four Councilmen were unable to reach a consensus.

**Analysis &
Conclusion:**

As of June 30, 2011, there will be one vacancy on the Paso Robles City Library Board Committee. Two candidates, Pamela Alch and Nancy Major, have applied for the position. Council was unable to reach a consensus at a public advisory board interview session held May 26, 2011.
