Needs: For the City Council to consider awarding a contract to install bus seating and

passenger lifts in the transit fleet.

Facts:

1. The City received an American Recovery and Reinvestment Act (ARRA) transit grant to install replacement seating and passenger lifts in the city

amount available for the lifts is \$22,400,

2. Bids were solicited for these projects, and one bid was received for each, both from Creative Bus Sales, Inc.

transit vehicles. The grant amount available for the seating is \$56,576 and the

3. The bid for seat installation was under the projects budget, while the bid for the Lift Installation exceeded to project budget. To prevent the City exceeding the available financial resources, the scope of the lift project has been modified, with the agreement of the contractor, to five lift installations instead of the originally planned seven. The revised project scope will cost \$21,514, which will be covered by the available budgeted ARRA funding.

<u>Analysis &</u>

Conclusion: Staff reviewed the bids and found them to be responsible and responsive.

<u>Policy</u>

Reference: Resolution # 11-105 accepting the ARRA project revised budgets.

<u>Impact</u>: All the expenses for the seating install and lift install projects will be paid for by

the ARRA grant. However, ARRA grant funds come through a reimbursement process, and the City Transit Fund would be responsible for the initial outlay of

funds. The funds would then be reimbursed once the projects are complete.

- A. Adopt Resolution No. 11-XXX awarding the contract to install transit vehicle seating for a not to exceed cost of \$51,430.06 and transit vehicle lift for a not to exceed cost \$21,514.00 to Creative Bus Sales, Inc. or
