- SUBJECT: ADD CORTNEY E. POOLE TO THE CITY'S PRE-APPROVED CERTIFIED ARBORIST LIST
- DATE: September 6, 2011
- Needs: For the City Council to consider adding one new Arborist to the City's Certified Arborist consultant list.
- Facts:
- 1. Chapter 10.01.040 of the City Municipal code requires that a person who provides services as an Arborist in the City must be certified by the Western Chapter of the International Society of Arboriculture (ISA) and must be on a list of Certified Arborists approved by the City Council.
- 2. The purpose of the pre-approved arborist consultant list is to ensure that only ISA-certified arborists are used by applicants in addressing oak tree issues.
- 3. The following Arborist has requested to be added to the City's List to do work within the City boundaries (see Attachment 1, Applicant Letter):

Cortney E. Poole, ISA Certificate Arborist: #WE-8984A

- 4. Cortney Poole has returned a signed statement acknowledging that she understands the conditions under which the City will accept her for approval on the List (Attachment 2).
- 5. Staff has reviewed the qualifications for Ms. Poole and found that she is qualified to provide consulting services and to prepare arborist reports to the City pursuant to Chapter 10.01 requirements.

Analysis and Conclusion:

Iusion: The Oak Tree Protection Ordinance (Municipal Code Chapter 10.01) was amended in September 2002 to strengthen the protection of oaks in the City of Paso Robles. The amended code requires that an arborist consulting in the City must be certified by the ISA as qualified to determine whether an oak tree is diseased, and able to make recommendations regarding pruning, cutting, and preservation measures.

Ms. Poole was sent a copy of the Oak Tree Protection Ordinance and Oak Tree Evaluation Criteria, and was asked to sign a statement that she had read the Ordinance and agrees to conform to the City's criteria for evaluation reports. She responded in writing to provide their certification number and current address/telephone and e-mail information. In addition, Ms. Poole was advised of the need to obtain a City Business License to perform work in the City.
