SUBJECT: Sherwood Park – Volunteer Project to Construct New Baseball Field

DATE: February 5, 2013

Needs: For the City Council to consider Paso Robles Youth Baseball's (PRYB) offer to construct a new baseball field at Sherwood Park.

Facts:

- 1. On October 9, 2012 City staff received a proposal from PRYB requesting permission to install a permanent baseball backstop, on-deck circle and dugout at Sherwood Park, increasing the number of permanent baseball fields at Sherwood from 2 to 3.
- 2. The Sherwood Master Plan calls for a total of two baseball fields and additional parking spaces in the vicinity of the current tennis courts.
- 3. No City funds will be expended for construction of the ball field; Paso Robles Youth Sports Council has pledged up to \$13,000 in support of this project which is estimated at \$12,500. PRYB has additional funds should the project exceed this amount.
- 4. All labor for the project will be provided by volunteers from PRYB and the Paso Robles Youth Sports Council and will be under the direction of licensed building contractors.
- 5. City Public Works staff have favorably evaluated the feasibility of the project and have indicated that Americans with Disability Act requirements associated with new construction may be accommodated via a hardship application for which PRYB is in the process of applying. This application would allow the group to restrict spending on ADA improvements to 10% of the total cost of ball field construction.
- 6. Members of the Parks and Recreation Advisory Committee unanimously endorse this proposal.
- 7. Frequent users of the adjacent tennis courts, youth soccer representatives and residents in the Sherwood Park area have been notified of this proposal and have voiced no objections to the project.

Analysis & Conclusion:

Noting the critical need for additional baseball fields, the PRYB organization has submitted a proposal to construct a new field at Sherwood Park. Although the proposal calls for a deviation from the Sherwood Master Plan, it has been evaluated and endorsed by City staff, advisory members and stakeholders. No objections have

been raised by residents in the Sherwood neighborhood, and the group intends to fund this project with no assistance from the City.

Policy

Fiscal

Impact: The Paso Robles Youth Sports Council and PRYB will cover all costs associated with

this project, including labor.

Options:

a. Authorize the PRYB organization to install a permanent baseball backstop, on-deck circle and dugout at Sherwood Park.

b. Amend, modify, or reject the above option.



To Whom it May Concern:

The following is a request to install a permanent baseball backstop, on deck circle, and dugout at Sherwood Park located on the corner of Scott Street and Creston Road. Included in this request is a schematic of the playing field at Sherwood Park and proposal of all costs and labor. Cement will be poured in both the on-deck circle as well as the dugout to reduce maintenance around the area, other than mowing. The proposed backstop will be identical to the existing backstop located on the north side of the park (Tom Silva Field). The dimensions are twenty feet (20') wide with ten foot (10') sides. An additional twenty-two feet (22') of fencing will be added to accommodate an eight foot (8') on-deck circle and a fourteen foot (14') dugout.




